SECTION 4: The conduct of games of chance shall be permitted on the first day of the week, commonly known and designated as Sunday, except that no games of chance shall be conducted on Easter Sunday, Christmas day or New Year's Eve, as provided in Section 195 of the General Municipal Law.

SECTION 5: The powers and duties set forth in Section 194(1) for the control and supervision of games of chance conducted in the Town of Machias shall be exercised by the Sheriff of Cattaraugus County.
