<u>Highway Superintendent</u> Mr. Barber presented the Highway report. The Highway department has been chipping brush and trimming trees. New pricing on the pickup truck will be available in March. Current pricing for a Ford is \$58,200 without a plow and without trade in value. Five Star will be coming out to appraise the loader. The excavator is a higher priority than the loader now. The excavator is constantly needing repairs. He asked for the Board to consider taking responsibility for Traffic Street. It is the shortest way to Springville. He feels it would only take a years' worth of CHIPS funds to get it upgraded to open it year round.

<u>Councilmember Paul Stang</u> Mr. Stang announced the return of the Otto VFD Pancake Breakfast. It will be held on February 5<sup>th</sup> from 8am to noon. \$10 a plate.

<u>Code Enforcement Officer</u> Jeff Holler reported on his activities for the month from 11/15/22-01/17/23. He took eight calls. He issued two permits, the first at 8402 North Otto Rd for an Ice house, barn remodel and wood stove, the second at 9350 Dunkleman Hill for a solar permit extension. He conducted four inspections. \$53789.920 was deposited with the Town Clerk.
