CALL TO ORDER

Supervisor Heath called the meeting to order and led in the pledge of allegiance.

PRIVILEGE OF THE FLOOR:

Robert Rein Town of Gerry resident and member of the Gerry Fire Department addressed the Gerry Town Board as to what could happen on April 8^{th,} 2024, when the Solar Eclipse takes place as we are in the line of totality and the possibility of issues that may occur with the influx of people in our area. Robert Rein noted that there is not a hotel room that can be booked as they have been rented for over a year, and if the weather is not cloudy then there will be thousands of people that could be on our roadways and in our town watching the eclipse, Mr. Rien stated that they will just pull over on the side of the road and watch this could cause traffic issues along with emergency issues if we can't keep our roads open. He also stated that the Fire department is a shelter and asked if the Town of Gerry could block off the reserve center as that is the designated site for the helicopter if it is needed. The Town Highway will take care of the Reserve Center on the day of the eclipse as they cannot have people parking in there. Mr. Rein stated that the Rodeo Grounds will be blocked off as they do not want anyone getting stuck in there,

COMMUNICATIONS:

The Town of Gerry received a communication from NYS DOT that they will be working on the sidewalks and crosswalks at the four corners, along with making a 45-mph section headed south a no-passing zone by putting in double solid lines. Supervisor Heath noted that he has asked to have a crosswalk be put at the park across from Heritage Village as we have kids that cross there along with people from the nursing home, and it is a dangerous spot to cross. The NYS DOT is looking into this issue and will get back to the Town of Gerry.
