## **Departmental Reports:**

Town Clerk report for January submitted and on file. Monthly fees remitted totaled \$27,537.05 and disbursed as follows; Supervisor-A Fund: \$2,858.42, B Fund: \$100.00, Sewer User Fees-SS1 Fund: \$22.284.97, Sale of Water- SW3 Fund: \$2.189.41, NYS DEC license sales: \$47.25, NYS Animal Population Control program: \$67.00. NYS DOH Marriage License: \$90.00. 37 Record Requests were completed and 4 Marriage licenses issued. February dog license renewals mailed on 1/26/24 along with 2<sup>nd</sup> reminders and phones calls for all expired licensed.

Penalties posted for all unpaid balances for Water District 3 and Sewer District 1.

Penalty free period for the 2024 Town/County tax collection ended Feb 6<sup>th</sup>. Total collections and Deposits to date: \$10,583,647.66. Disbursements have been made to the Supervisor in accordance with the 2024 Tax Warrant. 1% penalty is now in effect through 2/29/24. 2<sup>nd</sup> Notices will be mailed by the end of February for all taxes remaining unpaid.

Assessor's report submitted and on file. The office is continuing their fieldwork for new construction and demolition projects, processing exemption renewals, and providing apportionments as needed.

Code/Zoning report submitted and filed. 12 Permits issued for the Town with project total of \$440,550.00 and 6 for the Village with project total of \$434,500.00. 31 Permits were closed for the Town totaling \$642,533.23.00 in project value and 5 for the Village totaling \$18,200.00 in project value.

The Town Zoning Board met with Wendell Engineering on Jan. 16<sup>th</sup> to review and discuss the proposed Battery Energy Storage Law. Sol Source is on the February meeting agenda to discuss revised plans for the solar project on Wright Rd.

Highway report was submitted and filed with the Town Clerk. The department lowed and sanded for 21 days. Completed chewing brush behind ditches. Cleaned up limbs and trees from windstorms and started cutting dead trees. Performed maintenance on equipment.

Due to employee safety concerns and increasing costs associated with Spring cleanup, the Department is looking to eliminate the curbside pickup and obtain roll offs for residents to transport and dispose of items at the highway barn. This has proven to be effective for several other Towns. The department is proposing to add Saturdays to the regular cleanup week and possibly a couple of evenings during the week. Last year, 124 tons of debris was picked up and removed costing a total of \$37,000.00 in fuel, equipment, labor and disposal fees. Even by adding the additional collection hours, the proposed change would cut costs by approximately \$20-25,000.00. Details will be worked out with the Clerk's office and notices will be mailed out to all residents with the proposed changes.

## Public Comment (Non-Agenda Items):

Julie Lecsynski addressed the Board complimenting the Code Office for their productive assistance with the issues on Beaujean Rd. Dawn Freeman stated she had various pictures of the code issues on Beaujean Rd. and would submit them directly to the Code Enforcement Office.

Jane Conroe of the Chautauqua-Conewango Consortium, an advocacy organization protecting waters, addressed the Board and distributed a handout regarding various things that are misunderstood when it comes to lake health and herbicide treatment. Many of the plants found in the lake are native and serve a valuable role in the lake's ecosystem by providing food and cover for the fish, holding the bottom sediment in place and producing oxygen in the water. The consortium supports the Town in protecting these plants and deciding not to spend any more tax on unneeded maintenance.

Alan Bozer addressed the Board with his concerns on proposed changes to the spring cleanup for those residents that do not have the means to transport items for disposal. Councilman Carlson stated residents could contact the Highway Superintendent with any concerns.

Karen Engstrom referenced an article in the paper and commended the Board for their diligence and long-range assessment of the use of herbicides in the lake. The South basin is a good test of this. Recent information obtained from various fish and charter captains that watch the waters, indicated that areas where there are large amounts of seaweed, the lake is clear and the habitat is healthy. However, in the areas that have been treated with herbicides, this is not the case in which they have noticed an increase of blue-green algae and a noticeable decline in the habitat.

# Proposed Water District -Order Calling Public Hearing

#### The Establishment of Water District No. 5 in the Town of Chautauqua, Chautauqua County, New York

**WHEREAS**, the Town Board of the Town of Chautauqua, Chautauqua County, New York, has duly caused to be prepared a map showing the boundaries of a proposed Water District No. 5 in said Town (hereinafter, the "Water District No. 5" or simply, the "District"), a general plan to serve said District, and a report of the proposed method of operation thereof; and

**WHEREAS**, said map, plan, and report, including an estimate of the cost, were prepared by Barton & Loguidice, D.P.C., competent engineers duly licensed by the State of New York, and have been filed in the office of the Town Clerk of said Town, where the same are available during regular office hours for examination by any persons interested in the subject matter thereof, including estimate of cost; and

WHEREAS, the boundaries of said extension shall be as described in <u>Exhibit A</u> attached hereto and hereby incorporated herein; and

**WHEREAS**, the improvements proposed for said District consist of the installation of approximately 28,000 linear feet of 4" and 8" water main, including original furnishings, equipment, machinery, apparatus, valves, hydrants, appurtenances, and incidental improvements and expenses in connection therewith, all as more fully described in the map, plan and report hereinbefore described; and

WHEREAS, the maximum estimated cost of said improvements is \$9,312,000; and

**WHEREAS**, the proposed method to be employed for financing such improvement is the issuance of serial bonds, and

**WHEREAS**, the Town intends to apply to other sources of low interest loan and grant funding that would reduce the local costs and the cost estimates, including from the Water Infrastructure Improvements Grants and Drinking Water State Revolving Fund administered by the New York State Environmental Facilities Corporation; and

**WHEREAS**, the estimated cost of said District to the typical one- or two-family home therein is estimated to be between \$1,144 and \$1,633 in the first year in which operation, maintenance, debt service, and other charges and expenses are to be paid, depending on the project's final grant and loan funding package, and

**WHEREAS**, a detailed explanation of the manner by which were computed said estimated costs has been filed in the office of the Town Clerk at 2 Academy Street in Mayville, New York where the same are available during regular office hours for examination by any person interested in the subject manner thereof; and

**WHEREAS**, said capital project for said District and the establishment thereof has been determined to be an Unlisted Action pursuant to the regulations of the New York State Department of Environmental Conservation promulgated pursuant to the State Environmental Quality Review Act, the implementation of which as proposed, the Town Board has determined will not result in any significant environmental effects and a Short Environmental Assessment Form is available on file in the office of the Town Clerk where it may be inspected during normal office hours; and

**WHEREAS**, it is now desired to call a public hearing upon the question of the establishment of said District and the improvements proposed therefore, all pursuant to Section 209-d of the Town Law; NOW, THEREFORE, BE IT ORDERED, by the Town Board of the Town of Chautauqua, Chautauqua County, New York, as follows:

<u>Section 1.</u> A meeting of the Town Board of the Town of Chautauqua, Chautauqua County, New York, shall be held at the Chautauqua Community Building, 2 Academy Street, in Mayville, New York, in said Town, on the 13th day of March, 2024, at 7:15 o'clock P.M., Prevailing Time, for the purpose of holding a public hearing to consider the increase and improvement of the Water District in said Town as described in the preambles hereof, to be known as to the Water District No. 5, and the improvements proposed therefor, and to consider the map, plan and report filed in relation thereto, and to hear all persons interested in the subject matter thereof concerning the same, and for such other action on the part of said Town Board as may be required by law or shall be proper in the premises.

<u>Section 2.</u> It is hereby determined that all expenses of the Water District No. 5, including all Districts heretofore or hereafter established, shall be a charge against the entire area of said Water District No. 5, including said District hereinbefore described.

Section 3. The Town Clerk is hereby authorized and directed to cause a copy of this order to be published once in the Jamestown Post-Journal, the official newspaper of said Town, the first publication thereof to be not less than ten nor more than twenty days before the day set herein for the hearing as aforesaid, and said Town Clerk shall also cause a copy thereof to be posted on the sign-board of the Town maintained pursuant to subdivision 6 of Section 30 of the Town Law not less than ten nor more than twenty days before the day set for the hearing as aforesaid.
