This undertaking of the Town Clerk and Tax Collector is further conditioned that she will well and truly keep, pay over and account for all moneys and property coming into her hands as such Town Clerk and Tax Collector; and

This undertaking of the Town Justices is further conditioned that they will well and truly keep, pay over and account for all moneys and property coming into their hands as such Town Justices; and

The Town does and shall maintain insurance coverage, presently with Vanner Insurance, in the sum of \$1,000,000 for the Tax Collector, Town Clerk and Supervisor to indemnify against losses through failure of the officers, clerks and employees covered there under faithfully to perform their duties or to account properly for all monies or properties received by virtue of their positions or employment, and through fraudulent or dishonest acts committed by the officers, clerks and employees covered thereunder.
