**HIGHWAY BILLS:** Voucher December 2023 #186-196 totaling \$5,819.53 and January 1-5,2024 1-5 totaling \$6,875.04, motion was made by Ryan Lepp and seconded by Matt Smith, all in favor to pay Highway Bills, none opposed.

**WATER BILLS**: Voucher #1-3 totaling \$\$1,732.88, a motion was made by Matt West and seconded by Ryan Lepp, all in favor of paying the Water Bills, none opposed.

**SEWER BILLS**: Voucher #1-8 totaling \$2,906.22 and Sewer Ban #1-#2 totaling \$11,545.75 a motion was made by Matt West and seconded by Ryan Lepp all in favor to pay Sewer Bills, none opposed.

**CODE ENFORCEMENT/ASSESSORS REPORT**: Jayson reported on the Nobles project.

**JUDGES REPORT:** A motion was made by Ryan Lepp and seconded by Matt West to accept the Judges Report, none opposed.

DCO REPORT: No report.

**MUSEUM REPORT:** Tim Nobles reported he is looking for information regarding the radar tower on Boutwell Hill and the late L.C Langworthy family from Cherry Creek. **HIGHWAY:**

- \*1 A's have been hauled for the 2024 sealing program.
- \*Ken asked the Town Board to purchase a man lift for tree trimming in the amount of \$10,000-\$12,000. Reported it isn't really feasible to rent one due to the weather. Board asked Ken to get prices and a clean service record and bring the information to the February meeting. Jim Abbey will check for prices at United Rental.

**WATER/SEWER REPORT:** Dustin Sheldon reported to the Board that his inspection from the County is weather permitting for wells #1 and #3.

- \*Plow is working good with the extentions.
- \*FSC installed cameras at the park.
