Supervisor Wasmund called the regular board meeting to order at 7:00pm with a quorum present.

<u>Supervisor Wasmund</u> Mr. Wasmund presented the Board with his monthly report. Mr. Wasmund provided a copy of the Proposed Local Law No. 1 of year 2023 as drafted by the attorney.

Resolved that the minutes of the February 2023 meeting are approved as written.

Highway Superintendent Mr. Barber reported on the activities of the highway department. They have had the broom out to take off the first layer of road grit. They have been doing some ditching on Skinner Hollow Road. A thin layer of pea size gravel has been put down. The blue truck is still being serviced it has continued to act up. The posting for the excavator on Auctions International has ended with a bid of only \$19,900.00. He wanted to see at least \$30,000. The Town could still get the trade in quoted at \$25,000 from Alta Equipment with the purchase of the used excavator. The letter of intent to purchase is expiring today. The department generally puts 500-600 hours on the equipment annually and Mr. Barber feels it's a valuable purchase for the Town. Mr. Barber has acquired three quotes for the demolition of the partially collapsed building on Main Street.

<u>Code Enforcement Officer</u> Jeff Holler reported on his activities for the month from 2/21/2023-03/21/2023. He took nineteen calls. He conducted six inspections. No building permits were issued this month. Mr. Holler discussed how the zoning law is unique to our Town and that if a cleanup law were to be acted upon the County wouldn't reimburse the Town for those expenses if they were applied as a lien on the property taxes. A letter of intent needs to be sent to the home owner and he believes written permission needs to be given from the property owner before the Town can demolish the building.

Tax Collection : An analysis of Collections of the current tax collection period was distributed to the Board. Total overall collections as of 03/21/2023 is \$1,294,671.14 on 659 parcels. 98 parcels are still outstanding.

Assessors Report via Email:

 Because exemption renewal applications are due March 1, February is always one of our busiest months-- answering tax payer questions, processing applications, contacting applicants for additional information, etc. In order to best serve these applicants, we also take time to call those who haven't returned a renewal application, reminding them the deadline is quickly approaching. Reminder letters are sent to the handful we do not have good phone numbers for.

 Renewal applications for Agricultural Assessment and Senior Citizen Exemption are being submitted and processed. So far, 94% of Agricultural Assessment and 80% of Senior Citizen renewal applications have been processed. The Assessing Office has corresponded with several property owners about their assessments, tax bills, and exemptions.
