Supervisor Wasmund called the regular board meeting to order at 7:00pm with a quorum present.

<u>Supervisor Wasmund</u> Mr. Wasmund presented the Board with his monthly report. He discussed with the board correspondence from Brady & Swenson regarding their proposal for legal representation. Mr. Wasmund inquired on receipt of a bid for the Town Hall roof. A bid has not come in. Dan Steinbar has been recommended to fill the vacancy on the variance board. A resolution was requested to appoint Mr. Steinbar to the board.

<u>Highway Superintendent</u> Mr. Barber reported on the activities of the highway department. The highway crew assisted East Otto, New Albion and Mansfield on their chip sealing projects over the month. They hauled in 246 ton of shoulder material running 23 trucks. The pipe on Whitcomb was changed out and the culvert on Dake Hill was replaced. The guys have been mowing in between paving jobs.

**Code Enforcement Officer** Jeff Holler reported on his activities for the month from 6/22/23 thru 7/18/23. He took twelve calls. He conducted eleven inspections. Three permits were issued. The first at 9581 Marek Road for a shed. The second at 8580 Dake Hill Road for a single family residence. The third at 9693 Hill Road for a pole building. Five violation notices were sent. He submitted the information and complaint form to the Judge. Mr. Holler attended the planning board meeting. \$330.00 was turned over to the Clerk.

<u>Councilman Stang</u> Mr. Stang read letters of gratitude for the life saving measures taken by members of the Otto Fire Department on a rescue call on North Otto Road. Mr. Stang asked if there were any thoughts on hosting the 200 year anniversary for the Town. Many ideas came forward. No official committee was formed.
