NYMPA is responsible for the managing the power supply, maximizing your available hydropower from the Niagara Project, working with the markets to secure the supplemental electricity that your system needs over and above the hydropower needs supply by NY Power Authority. Some of the challenges you may be facing are in common to what others are facing. Hiring for Line Workers, Capital Planning, Asset Improving, Replacement Buildouts and Rates are all challenges in everyone's systems. We are here to help, with lots of resources available. We've observed a lot of our systems haven't applied for a rate increase in years. Again, resources are available to help.

ELECTRIC DEPARTMENT:

Sr. Line Worker Imhoff gave an overview of what the Electric Department needs are. Both substations need 3 regulators each, a 3-phase gang switch at the metering point, 2 breakers at the 4th St. substation. The 3rd St. substation needs to be replaced and moved to a new location and needs major updates. We need to look at a backup transformer setup at the 4th St. substation, 3 transformers are needed for the water wells and possibly need a 3-phase setup for the Airbnb going in on 4th St.

Apprentice Line Worker Pilon presented the board with a list of possible quotes for a new digger derrick that the Electric Department needs to replace the current 1996 digger derrick. The main concern to replace the old digger derrick is because it is rotted out in the back.

- Altec \$406,387 with radio control wait time 24-36 months.
- Terex \$380,000 \$425,000 with radio control wait time 24 months.
- Ring Power \$285,000 wait time is approximately 2 months needs lighting package.
- Custom Truck One Source \$278,615 wait time approximately 1-3 months.

The Digger Derrick Proposal will be tabled until the Trustee's can review the financials.

STREETS/WATER SUPERINTENDENT:

We have been changing out water meters, approximately 50 water meters in the last week. We have about 80 more to finish with residential meters. Trees are being cleared out at the well site. This is where our future water treatment building will go. We looked at the water rates and determined that an increase is needed. We figured 25¢ to the base rate and 75¢ to the per thousands.

The Sewer Department would like to purchase a generator for the pump station on Ninth Street. We have received two quotes.

- BECC Electric \$11,310.00 20KW 3 phase stand by generator.
- LED Electric \$12,200.00 24KW Generac.

Streets Supervisor Gross recommends the local business, stating if something goes wrong, they are right here.
