### LEGISLATOR'S REPORT

COUNTY LEGISLATOR CHAGNON REPORTED: THE LEGISLATURE INCREASED THE 2023 BUDGET FOR SAFETY NET COSTS BY \$2.96 MILLION DUE TO INCREASED COSTS. SAFETY NET COSTS ARE FUNDED AT 28% STATE, 1% FEDERAL, AND 71% COUNTY. THE 2023 BUDGET FOR SAFETY NET COSTS WAS \$5.5 MILLION. SAFETY NET ASSISTANCE PROVIDES CASH ASSISTANCE TO ELIGIBLE NEEDY INDIVIDUALS AND FAMILIES WHO ARE NOT ELIGIBLE FOR FAMILY ASSISTANCE. FAMILY ASSISTANCE PROVIDES CASH ASSISTANCE TO ELIGIBLE NEEDY FAMILIES THAT INCLUDE A MINOR CHILD LIVING WITH A PARENT/PARENTS OR A CARETAKER RELATIVE. ELIGIBLE ADULTS ARE LIMITED TO RECEIVING BENEFITS FOR A TOTAL OF 60 MONTHS IN THEIR LIFETIME, INCLUDING MONTHS OF ASSISTANCE GRANTED IN OTHER STATES.

#### SAFETY NET IS FOR:

- SINGLE ADULTS
- CHILDLESS COUPLES
- CHILDREN LIVING APART FROM ANY ADULT RELATIVE
- FAMILIES OF PERSONS FOUND TO BE ABUSING DRUGS OR ALCOHOL
- FAMILIES OF PERSONS REGUSING DRUG/ALCOHOL SCREENING, ASSESSMENT OR TREATMENT
- NON-CITIIZENS WHO ARE ELIGIBLE FOR TEMPORARY ASSISTANCE, BUT WHO ARE NOT ELIGIBLE FOR FEDERAL REIMBURSEMENT

THE LEGISLATURE INCREASED THE 2023 BUDGET FOR MENTAL HYGIENE LAW BY \$500,000, WHICH IS FUNDED 100%BY THE COUNTY. THE 2023 BUDGET FOR MENTAL HYGIENE LAW WAS \$250,000. THIS PAYS THE COST OF CARE, MAINTENANCE, AND SERVICES IN NYS OFFICE OF MENTAL HEALTH FACILITIES FOR INDIVIDUALS DEEMED BY CRIMINAL COURTS OR FAMILY COURTS AS UNABLE TO STAND TRIAL.

#### HIGHWAY SUPERINTENDENT'S REPORT

HIGHWAY SUPERINTENDENT HALLBERG NOTED THAT HIS DEPARTMENT HAS BEEN WORKING ON EQUIPMENT MAINTENANCE AND BECAUSE THE WEATHER HAS BEEN SO NICE, THE EMPLOYEES ARE REPLACING THE 4 X 6 POSTS AT THE TOWN PARK. THE CEMETERY WORK HAS BEEN FINISHED. THE GREENHURST AVENUE DRAINAGE PROJECT HAS PROGRESSED TO THE POST-OFFICE AND IF THE WEATHER ALLOWS MORE WORK WILL BE DONE THIS YEAR. THE DEPARTMENT WILL TRANSITION TO 2 SHIFTS WHEN NEEDED. MR. HALLBERG CONCLUDED HIS REPORT NOTING THAT THE NEW MOWER HAS BEEN RECEIVED.
