SENIOR LINE WORKER:

Since the last meeting, the Electric Department has completed and energized a line extension for a new customer out on Bucktooth Run. We've been clearing the right of way for line extension on Fourth Street for a new customer. We've been working on yearly inventory. Also, the meter testing program is ready to launch. Projects to come are on site meter testing, finish inventory requirements, finish build at Fourth St Air B&B, tree removal on Mill Street, and obtaining quotes for a new Digger Derrick. I would like to advertise for 35' poles.

STREETS/WATER SUPERINTENDENT:

Update on the Water Project – Northrups has finished Eighth Street from Erie Street to Fair Oak Street. They have tied in Eighth Street and Virginia Avenue to make a loop. They have Seventh Street and Fair Oak Street tapped and most of Seventh Street down to Erie Street. The road crossing Sixth Street and Fair Oak Street is done. Tomorrow, February 28th, they hope to drill the last service on the bottom on Main Street so we can shut off the old main on the bottom on Main Street, Sixth Street from Court St, South Court Street, Railroad Avenue to the bridge and Third Street.

We have started sweeping and will continue sweeping next week. We are also going to start cleaning up plow damage. I plan on leveling the water project when I'm on the streets. Northrup has started taking the extra dirt on Court Street.
