## ENACTING CLAUSE

Pursuant to the authority conferred by §1660 (a) (18) of the Vehicle and Traffic Law and Article II of the Municipal Home Rule Law of the State of New York, the Town Board of the Town of Machias does hereby enact the following Local Law establishing parking regulations on certain streets in the Town of Machias.

## ARTICLE II

## PARKING REGULATIONS

Section 1: Parking prohibited in designated locations.

- A. The parking of vehicles is hereby prohibited in any of the following locations:
  - 1. On the south and north side of Franklin Street within the Hamlet of Machias from the east curbline of State Route 16 easterly 60 feet.
  - 2. On the north and south side of Union Street within the Hamlet of Machias from the west curbline of State Route 16 westerly 60 feet.

## ARTICLE III

Any violation of this law shall constitute a violation and be punishable by a fine of up to Five (\$5.00) Dollars per violation. Any parking for a period in excess of twenty-four (24) hours shall constitute separate violations for each twenty-four (24) hour period or portion thereof.
