BID AWARD BELSON CREEK DAM RESTORATION CONTRACT

Resolution 61-2021 Town of Ripley Awarding Belson Creek Dam Restoration Contract

Whereas the Town has previously advertised for suitable contactors to submit sealed bid proposals for the public work involving the reconstruction and restoration of certain facilities at the Town's Water Storage Reservoir and Dam which is to be funded by U.S.D.A. Rural Development, and

Whereas the Town received one bid from H&K Services Inc. of Leon, N.Y., at the appointed time and date on which bids were due, and

Whereas the bid received was thereafter the subject of negotiations to reduce the amount of the bid price, to benefit the Town and Water District 1, and

Whereas the Town has requested authorization from U.S.D.A. Rural Development to award the Contract to H&K Services as revised at the lower total project cost, and

Whereas the Town has received said authorization from U.S.D.A. Rural Development,

Now Therefore it is resolved to award the contract to H&K Services Inc. in accordance with the bid proposal of \$158,200.00 for the public work as specified in the revised description of the work prepared by the Town's engineers Clark, Patterson and Lee and the Supervisor is directed to execute the necessary contracts with H&K Services Inc. as prepared and approved by the Town's engineers Clark, Patterson and Lee.

REVISED HOST COMMUNITY AGREEMENT LOVES TRAVEL STOP & COUNTRY STORE, INC.

RESOLUTION 62-2021 TOWN OF RIPLEY

APPROVING HOST COMMUNITY AGREEMENT LOVE'S TRAVEL STOPS AND COUNTRY STORES, INC.

WHEREAS, the Town has previously approved a special use permit for the development of a Love's Travel Stop and related facilities to be located within the Town along Shortman Road, and

WHEREAS, as part of the project, Love's has applied for financial assistance from the County of Chautauqua Industrial Development Agency, which among other benefits provides tax relief for the project for a specific period following the start of project operations, and

WHEREAS, also as part of the project consideration attention is given to the impact of such facilities on the local public infrastructure, specifically the Town's water and sewer facilities that would serve the project, and

WHEREAS, given said impact it is necessary to provide for an agreement between the Town and Love's which will provide annual payments from Love's to the Town as a consequence of said impacts, and

WHEREAS, a Host Community Agreement has been proposed between the Town and Love's which is also a component of the conditions for Love's Application for financial assistance with the County of Chautauqua Industrial Agency which is now pending, and

WHEREAS, Love's counsel has requested certain changes to the original agreement which do not change the respective obligations of the Company nor benefits to the Town,

NOW THEREFORE IT IS RESOLVED THAT, the Town Board having received the proposed amended Host Community Agreement which is attached hereto and made a part hereof, finds as follows:

I. That the proposed agreement properly deals with the issue of project impacts that are likely to result as a consequence of the Love's Project.

2. That the proposed schedule of annual payments made by Love's to the Town will be allocated as needed to the Town Districts as specified and as determined by the Town Board.

AND BE IT FURTHERED RESOLVED, that the Town Board approves the Host Community Agreement as set forth herein, and

BE IT FINALLY RESOLVED, that the Town Supervisor is authorized and directed to execute the Host Community Agreement on behalf of the Town.
