Supervisor Cox called the meeting to order at 7:00 p.m. and all in attendance stood for the Pledge of Allegiance.

Amanda Preston voiced her concern regarding the progress of the zoning that she had inquired about in September. Supervisor Cox stated that it has not honestly been addressed much further, other than to inquire about a Comprehensive Plan which would then lead to setting up a Planning Board and from there, some zoning could be established. The issue stems from a dwelling on South Main Street that is rat infested as well as littered with debris and garbage. Mike Unfus, Code Enforcement Officer, stated that the downstairs apartment of the building has been "placquered" and deemed condemned, but the other two apartments in building have not. Mike Unfus advised Amanda and the other concerned citizens who were with her to call the MACE office and file a complaint. Councilman Hillman volunteered to contact Kier Durham, Director of Planning of Allegany County, to walk through the process of establishing a Comprehensive Plan. From there the Town can appoint a Planning Board and then possibly establish some zoning laws. At 7:45 when Amanda and her group left, no one in attendance felt they had solid answers.
