Board Comments:

Supervisor Comments: James read the bicentennial proclamation and thanked everyone for their hard work putting events together.

Proclamation Honoring Township of Cuba's Bicentennial celebration year

Whereas, the Township of was designated by the New York State Legislature a Township on February 4, 1822 and is celebrating its 200th Anniversary; and

Whereas, in its first 200 years has transformed from a humble pioneer town into a leader in local government covering 35.8 square miles with nearly 3,300 residents calling Cuba "home"; and

Whereas, Cuba Township combines an eclectic blend of cultures, shops, businesses and recreational opportunities which make it a popular and in-demand "place to be";

Now, therefore, be it resolved, I, Lee Sweet James, 45th Supervisor of the Township and the members of the Cuba Town Board hereby proudly announce and proclaim that we take pride in everything Cuba has accomplished in its two hundred years and are pleased to spend this year honoring and celebrating its legacy.

Librarian Tina Dalton presented the financial changes that the library is looking at for this year. The library would like to become fully funded by school taxes and not be reliant on municipal funding. She hopes that the

proposal will pass the Library Budget Vote but if it does not pass, she would ask that the Town of Cuba still support the library with municipal funds.

Minutes for 01/11/2022, Supervisors Report for January & General & Highway Abstracts for February:

When asked, board members responded yes, they had reviewed the minutes, reports and abstracts.

<u>The Supervisor's Report</u> showed the general fund received \$56,773.98. The highway fund received \$27.27. Disbursements include \$145,399.36 for general and \$39,059.74 for highway.

<u>The February Abstract #02</u> dispersed \$23,751.60 from the General Fund and \$21,343.67 from the Highway Fund

On the motion of Farwell and seconded by Conklin the reports were accepted as presented.

<u>Clerk Comments</u>: Check has been given to Supervisor in the amount of \$2,045.511.99 and to the County Treasurer in the amount of \$1,677,315.00 to satisfy all of the Town of Cuba's tax warrant and a portion of Allegany County's.

Assessor's Comments:

- Village partial tax exemptions, 27 were sent out and 11 have been returned
- Town partial tax exemptions, 38 were sent out and 27 have been returned
- The equalization rate will drop from 83% to 74%
- There will no longer be star available to mobile homes that are in a park

Police Department Comments: In the month of January the department conducted 17 traffic stops, 3 in the Town, 3 in the Village, 5 on the Lake, 0 on I-86 for a total of 11 uniform traffic tickets issued. 10 motor vehicle accidents occurred, 7 in the Town, 1 in the Village, 1 on the Lake, and 1 on I-86. There were 113 calls for service. Two officers are attending field training, the town will only have to pay for one.

<u>Ambulance Comments</u>: The Cuba Ambulance Service responded to a total of 13 calls to service in January of 2022. 4 of those calls were taken to Olean General Hospital, 1 was taken to Jones Memorial Hospital and 8 were sign offs, 0 was mutual aid, 0 were standby, 0 were taken by Mercy Flight and 2 were DOA. 3 of these calls were critical care with Cuba handling 2 and Olean 10/MTS handling 1. 4 of these calls were in the Village of Cuba, 5 were in the Town of Cuba, 0 were on the lake, 0 was mutual aid to Friendship, 0 was mutual aid to Clarksville, 3 were to New Hudson and 1 was on I-86.

- We have purchased the I am Responding App for a year and are actively using it.

Highway Comments:

- Plowed snow 15 times
- Pushed up sand

Smith presented prices on a new truck, he suggests that the Town purchase a Freightliner 114SD Truck Cab and Chassis with the Viking Stainless Steel Dump Body and Equipment for \$242,187.21.

The board agreed to purchase the Freightliner on the motion of Conklin and seconded by McGraw. All in favor, passed.
