<u>Supervisor Wasmund</u> Mr. Wasmund presented the Board with his monthly report. Mr. Wasmund has been looking into the insurance on the Town barns and building. He attended the last school board meeting. There has been no word on the allocation percentages for a pilot amount. Sharon Huff stated they would go with what the IDA has decided for the pilot payment percentages. She is now wanting to keep the 55%.

Paul Stang Mr. Stang mentioned that the lights are still on at the historical museum. He wanted to know when they should be turned off now that it is past the winter holiday season.

<u>Kevin Walker</u> Mr. Walker had attended the zoom meeting with Ron. He is still trying to find avenues of funding for the renovation of the Town building.

<u>Highway Superintendent</u> Mr. Barber discussed the need to increase the amount of road bond that a company should obtain for over the roadway uses. He has been looking into getting a voltage protector. During the Brown out the generator worked very well.

Mr. Barber discussed the phone system issue. The phone lines are linked from one phone to the next and his phone is the beginning of the line and with his phone not working the others will not work properly. Ron Wasmond said he would look into the possibility of have DFT phone service.
