Section 1. Authorization of Appointment

The Town Board of the Town of Machias is hereby authorized to appoint officers who shall be known as "constables" and who shall possess all the powers and duties of constables in civil actions and proceedings, and shall be further authorized to file such informations and issue and serve such process as reasonably necessary to enforce laws and ordinances regulating the parking of motor vehicles on public streets and highways within the Town of Machias. Constables shall be subject to such regulations as the Town Board may adopt by resolution.

Section 2. Remuneration

Remuneration may be as determined annually in advance by the Town Board, but no salary shall be paid for the performance of duties in civil actions and proceedings. In civil actions and proceedings, constables shall be entitled to collect the statutory fees allowed by law.

Section 3. Tenure

Constables shall serve at the pleasure of the Town Board, and shall be appointed by the Town Board at the reorganizational meeting of the Town Board each year.

Section 4. Effective Date

This local law shall take effect immediately.
