He believes that the rocks that have washed down Savage Creek and onto his property are the result of the new culvert that was installed in 2020. He would like the Town to remove the rocks. The Town Board members explained to him that logging has been done on the top of the hill and the Town has received excessive rain amounts recently. There is also a foot bridge over the Creek that becomes clogged with debris and causes overflow. The culvert was installed correctly and is larger than the previous one. The Town resident is responsible for removing the rocks on his property.

- Due to recent emails from Dan Martonis from Catt. Co. on the handling of apportionments and recording split sales, the Board agrees that the Town Assessor should follow the rules of the County for reporting to the County on Assessing responsibilities.
- Supervisor Parker received a letter from Brad Camp from the City, to ask if the Town would be interested in the intermunicipal grants through EFC for water districts (including BOCES) for 2022. The Board agreed to this.
- Discussion was held on the American Rescue Funds spending. The Board decided to use some of the money for essential pay for the Town elected officials. Tentative plans for the remaining monies could be used for work on the Dugan East Sewer system, revenue loss, and road repair.
