SUPERVISOR ANDERSON CALLED THE MEETING TO ORDER AT 6:00 PM. THE PLEDGE OF ALLEGIANCE WAS OBSERVED

TOWN BOARD MEETING MINUTES - JUNE 9 AND 14, 2022

MOTION BY COUNCILMAN HAYES, SECOND BY COUNCILMAN CRESANTI: THAT THE BOARD ACKNOWLEDGES THAT THE MINUTES OF THE JUNE 9, 2022, TOWN BOARD MEETING AND JUNE 14, 2022 BOARD MEETING WERE PRESENTED.

MR. CRESANTI – AYE

MR. SCHLEMMER – ABSENT

MR. HAYES – AYE

MR. ANDERSON – AYE - MOTION CARRIED

JUNE REPORTS

TOWN CLERK, REBECCA HAINES, SUBMITTED HER JUNE TOWN CLERK REPORT IN THE AMOUNT OF \$11,533.00. THE CHECK TO THE TOWN TOTALED \$11,370.47.

TOWN CLERK HAINES ALSO NOTED THAT THE ASSOCIATION OF TOWNS MAY/JUNE TOWN TOPICS ADDRESSED THE FEDERAL TELECOMMUNICATIONS ACT OF 1996 (TCA), UNDER WHICH CONGRESS EXPLICITLY PRESERVED TO STATE AND LOCAL GOVERNMENTS THE "GENERAL AUTHORITY" TO CONTROL THE SITING, PLACEMENT, INSTALLATION, AND MODIFICATION OF CELL TOWERS AND OTHER WIRELESS FACILITIES WITHIN THEIR JURISDICTIONS. TO USE THE POWER PRESERVED TO THEM UNDER THE TCA LOCAL GOVERNMENTS MUST SIMPLY ADOPT A LOCAL ZONING PROVISION THROUGH WHICH THEY BOTH GRASP THAT POWER AND EXERCISE IT IN A MANNER THAT COMPLIES WITH THE PROCEDURAL CONSTRAINTS IMPOSED UPON THEM UNDER THE TCA.

TOWN ATTORNEY ROBINSON SAID HE WOULD LOOK INTO THE MATTER.

NEXT, TOWN CLERK HAINES DISPLAYED THE FIRST EXAMPLE OF THE SIGN TO BE DISPLAYED AT THE ENTRANCES TO THE TOWN. THERE WAS QUITE A REACTION TO THE COLORS AND IT WAS

AGREED AFTER SOME DISCUSSION THAT TOWN CLERK HAINES AND THE OFFICE PERSONNEL WILL BE LOOKING/DECIDING ON ANOTHER COLOR SCHEME FOR THE SIGNS.

THE TOWN BOARD REVIEWED/DISCUSSED THE JUNE REPORT FROM THE ZONING OFFICER, ANNE GOLLEY. TWO PROPERTIES SPECIFICALLY MENTIONED WERE THE ANDRIACCIO PROPERTY ON THE CORNER OF ROUTE 430(MAIN ST.) AND RALPH AVE. AND THE DENNIS HARVEY PROPERTY ON BELLEVIEW ROAD. MRS. GOLLEY SAID SHE IS CURRENTLY WORKING WITH VIOLATIONS ON BOTH PROPERTIES.

THE BOARD ALSO RECEIVED/DISCUSSED THE JUNE REPORT SUBMITTED BY CODE ENFORCEMENT OFFICER, BOB SAMUELSON. MR. SAMUELSON SAID HE IS CURRENTLY WORKING ON VIOLATIONS AT THE OLD MOBILE HOME PARK (LUCARIELLO) AND WITH MR. GRUBER WHO IS RENTING NEARBY THE OLD MOBILE HOME PARK. THE LUCARIELLO PROPERTY ON ROUTE 430 IS STILL IN THE ESTATE SO THAT MATTER IS ON HOLD FOR THE TIME BEING. THERE IS ALSO A PROPERTY ON THE CORNER OF HARVEY ROAD AND ROUTE 430 THAT IS BANK OWNED AND A SQUATTER IS CURRENTLY THERE AND CREATING A MESS OF THE PROPERTY.

IN ANOTHER MATTER, MOSTLY VILLAGE, DEBBIE LACHS (MAPLE STREET) HAS CUT DOWN A TREE THAT IS EITHER THE TOWN'S OR RIGHT ON THE LINE AND HAS THROWN THE TREE ON THE TOWN PROPERTY (BY THE DRIVEWAY). SHE OR SOMEONE LIVING AT THE HOUSE OR THE CAMPER SHE HAS MOVED IN, IS ACCESSING THE BACK OF THE PROPERTY BY DRIVING OVER THE TOWN PROPERTY.

MR. ROBINSON SAID HE WILL BE SENDING A LETTER NOTIFYING THE LACHS THAT THEY CANNOT TRESSPASS ON THE TOWN PROPERTY AND ALSO INFORMING THEM ABOUT THE MATTER OF THE TREE.

MR. SAMUELSON ALSO NOTED THAT THE REGAN'S WHO OWN THE PROPERTY NEXT TO THE TOWN HALL HAVE AGAIN BEEN NOTIFIED THAT THEY NEED TO CLEAN UP THEIR PROPERTY.

THE BOARD ALSO RECEIVED THE JUNE REPORTS FROM THE ASSESSOR, TOWN JUSTICES AND TOWN SUPERVISOR.

LEGISLATOR'S REPORT

LEGISLATOR CHAGNON REPORTED: THE LEGISLATURE PRESENTED COMMENDATIONS AND CERTIFICATES OF AWARD TO ALL COUNTY HIGH SCHOOL VALEDICTORIANS AND SALUTATORIANS; AFTER A PUBLIC HEARING, EXTENDED THE SOUTH CHAUTAUQUA LAKE SEWER DISTRICT FROM THE HAMLET OF STOW TO THE SOUTH BOUNDS OF THE NORTH CHAUTAUQUA LAKE SEWER DISTRICT TO COMPLETE PUBLIC SEWERS ON THE WEST SIDE OF CHAUTAUQUA LAKE. THE PROJECT WILL BE CONTINGENT UPON RECEIVING GRANTS AND NO-INTEREST FINANCING SUFFICIENT TO MEET THE STATE COMPTROLLER'S AFFORDABILITY GUIDELINES; AUTHRRIZED THE DISTRIBUTION OF MORTGAGE TAXES FOR THE PERIOD OCTOBER 1, 2021 THROUCH MARCH 31, 2022 – ELLERY WILL RECEIVE \$73,594, A 6% DECREASE FROM THE SAME PERIOD LAST YEAR; ACCEPTED A NYS DEPARTMENT OF HEALTH GRANT TO CONDUCT RADON OUTREACH, PROVIDE EDUCATIONAL MATERIALS, AND DISTRIBUTE RADON DETECTORS DESIGNED TO REDUCE THE PUBLIC HEALTH RIST FROM EXPOSURE TO INDOOR RADON.

MOTION BY COUNCILMAN SCHLEMMER, SECOND BY COUNCILMAN HAYES: THAT JEREMY CRIST BE APPOINTED TO FILL THE VACANT TOWN BOARD SEAT CREATED WHEN COUNCILMAN ANDERSON RESIGNED TO BECOME THE TOWN SUPERVISOR.
