SERVICE CONTRACT FOR PUBLIC TRANSPORTATION

BETWEEN

TOWN OF MACHIAS, CATTARAUGUS COUNTY, NEW YORK

and

THE ROCHESTER-GENESEE REGIONAL TRANSPORTATION AUTHORITY

The Town of Machias desires public transportation service for town residents with disabilities requiring transportation for services needed by them and not available within the town. Therefore, it is determined to be in its best interest to enter into a service contract with the Rochester-Genesee Regional Transportation Authority which is a public authority formed under the Public Authorities Law, Section 1299-dd for the provision of such services.

The Town, pursuant to Article 119-r, Section C, states that the a town may enter into a contract provided it has adopted a local law authorizing same which the Town has done.

It is understood that the Rochester-Genesee Regional Transportation Authority will designate one of its operating subsidiaries - the Wyoming Transit Service, Inc. to provide this service.

The Town of Machias shall incur absolutely no financial responsibility. The Rochester - Genesee Regional Transportation Authority shall hold the Town harmless from any legal liability whatsoever. This Agreement may be canceled upon sixty (60) days written notice by either party.
