**Trustee Todd Palmatier:** Asked out the new entry signs to the Village. He presented 3 quotes months ago, but project is still at a standstill. Would like to see the Street guys finish cleaning up the property on First Street to make room for more recreational fields. Would like to start advertising for summer help and lifeguards.

#### **CLERK TREASURER:**

<u>BUILDING & ZONING CODE ENFORCEMENT</u>: BCEO Helgager discussed property maintenance issues. Would like to start using a color-coded doorknob hanger system, so issues would be corrected within a 12-to-24-hour timeframe. Suggested that we budget for placards, which is required by state law, to post any condemned, inhabitable, or limited access properties.
