A motion by Mr. Westfall to go into executive session for litagation, it was seconded by Mrs. Tilton, was not brought to vote, The board invited in Attorney Mark Romaniski

A motion to come out of executive session at 7:17pm by Mrs. Tilton and seconded by Mr. Westfall, carried

the board proceeded to go over the bills and abstracts

A motion was made to accept the minutes by Mr. Westfall and seconded by Mrs. Tilton, carried.

A motion was made to pay the bills and to include the Auto Plus bill in the prepays by Mrs Tilton and seconded by Mr. Scurr, carried.

Hwy Report

Was read by Clerk Holmes- the board wanted to know what he wanted to replace first on his list of equipment and the board wanted to also ask him to write up the bid information to put out for the mower and to send it to the attorney for him to look at the wording of the ad.

Supervisor's report was read by Mr. Heberling

At this time Mr. Scurr questioned about the petty cash for the judges, he stated that it needed to be done with board resolution and not just with the supervisor writing a check and this was not done. At this time Judge Karcher stated that she has not had any need for petty cash money for the 21 years that she has been a judge. She explained that if she had cash on her

then she tries to break the money or she takes the whole amount and writes a check back to the person.

Mrs. Tilton and Mr. Scurr asked about the Machinery equipment and why is there a difference from the previous months. Mr. Heberling stated that Mrs. Berry and Mr. tingue had discussed the budget and they were both satisfied. Mr. Heberling made a motion to accept the supervisor's report no second. Mrs. Tilton made the motion to accept the the supervisor's report except for the 2 petty cash accounts and the last two supervisors' reports stay unaccepted till they get some answers, this was seconded by Mr. Scurr, carried

Town Clerk's report was read by Clerk Holmes and a motion to accept the report was made by Mrs. Tilton and seconded by Mr. Scurr, carried.

Justice Report- Justice Karcher stated that the only thing that she had was that the petty cash fund was in the control of Judge Lockridge and she wanted no part of it.

Mr. Scurr asked where the building permit money for the cheese plant that is part of the clerk's report was going and Mr. heberling stated that there was an account already set up for it in the Class portion of our banking.

Outside communications

Mrs. Tilton stated that last month the board had made a motion to investigate a pilot for the wind mills. With the lawyer stating that percentages that the town gets for the wind project changes with or with out the agreement. Mrs. Tilton presented a resolution requesting the Cattaraugus County Legislature and the Cattaraugus County Industrial Development Agency to support a Payment in Lieu of Taxes for the Alle-Catt Wind Energy Project. Mr. Scurr stated that they had made a motion concerning all mail was to go to the town hall and no residences and Mr. Heberling stated that it didn't matter as the justices do not work for the town.

Clark Rd

Mr. Westfall wanted to know about the Clark Rd and the lawyer stated that he had talked to Barry and he needed to see his form that he wrote up but at the present time Mr. Tingue was on vacation and he would reach out to him when he got back. Resident from Clark Rd Mr. Seymour stated that the work being done was in Lyndon and the road was not done yet. Mr. Sorgi stated that he thought the controversary was within the town and not from a neighboring town, he stated that he thought the paperwork should be recorded. Mr. Heberling made a motion to go into executive session concerning this road and no motion to second it was made. Mr. Heberling stated that the survey was emailed to everyone and others stated they did not get it.

Resident Elana Kozak stated that it being brought up emails, emails and other people are saying that they are not receiving them. Before a meeting all emails should be printed out and brought to the meeting in case someone has not gotten it.

Also stated that he felt that the resolution was flawed for the pilot and premature and it was only put on 24 hrs before the board meeting.

He wanted to know how a Freedom of Information request could be requested that fast? Also stated that there was lawsuits that were dismissed and there was paperwork concerning where he read some from one of them concerning statements from a Paul Bishop from the county.

Shawn Perry

From Inverengery wanted to clarify earlier statement about the paperwork not be completed and he wanted to clarify that there was things that were held up that what was the cause of the paperwork not be completed

Doug Thompson

Wanted to know why the lawyer did not know that putting Dale Scurr on as signature was not legal?

Lois Lane

Wanted the town board to rescind the resolution for Darling Rd
