Review and Approval of May 9th, 2022. -Motion by Larry Ball, Chris Jackson 2<sup>nd</sup>. All in favor.

#### Reports:

Supervisor: Finance Reports General Fund- Financial- Arkwright Summit Wind Monies received. Budget in good shape. Looking to have \$24,000.00 in reserve at end of year. \$1,200,000.00 going towards building. Highway side- \$500,000,00. Overall town in good shape. Starting 2023 6<sup>th</sup> year for the Wind Farm pilot checks should get 2% increase next year. Got to approve Budget transfer for new trucks.

EDP-Replacement for Blake- Gap in coverage- no replacement. Talk to Alex Gizowski. Asked Alex to reach out to his boss to contact us from Tug Hill.

## Highway Superintendent

Spending vs. Budget Update (Monthly) report –Lisa Waldron gave financial report. Spending-Snow removal- 70%, Construction & CHIPS- 2%, Macherinery-100%. Good shape everywhere else. Diesel- less than \$6.00 gal.- paid less \$5. -- /gal.

2022 Highway Construction Progress- Weaver- Started Christy- Drain tile going to be chip sealed and paved. Some grading done Miller & Tarbox- culvert changed Chip seal being done in August. Hall Rd- Ready for Final Offer? Cassadaga Wind offered- \$97,000.00. Would like to get \$100,000.00. Won't cover hard topping. Question is do we give Lisa Waldron approval to except dollar amount ---- or try to get more or get less. Limestone & chip. 1 Culvert does need to be replaced on Hall Rd. Tar & Chip Seal cracking. We will accept no less than \$97,000.00 but will try for \$100,000.00. Motion to Approve Highway Superintendent Accept Hall Road but Out Proposal from Cassadaga Wind Not Less Than \$97,000.00. Motion by Lynn Bedford, Bruce Gustafson 2<sup>nd</sup>. All in favor.

Report on Highway School- Very good. Very educational, learning about culvert and equipment. Update on Route 83 Project & Town's Involvement- 1 more day of milling. 6 towns involved. Ball Road Closure Plan/Mitigation Ideas- Will give notice 2 weeks ahead of closure. Will only be closed for 1 day. Will have everyone ready to go for the 1 day closure. Will run ad in local newspaper for 1 week prior to closing road. It will be July before we get to the project. The 3<sup>rd</sup> culvert is the one that we need to close the road for. W I will contact County EMS and Medical Emergency to see if they can work with us during the closure. Signs will be posted saying the road will be closing. Fields on both sides of the road are swampy and have ditches, hard to put in temporary road. Maybe check with Cassadaga Fire Company about a pumper to sit for the day, just for backup proposes. People will be informed.

Speed Limits- nothing- weight limit posted year-round.

Balls Gulf- section down to the bridge. Road is in pretty rough shape, Seasonal Road. Says travel at own risk. Took side by sides down it and it was pretty rough going on them. Should grade and get passable. Get open with a bridge and get passable is Plan A and then we can go to Plan B. Lisa Waldron Returned Checks to Jane Lindquist for overpayment on the new trucks purchased. County Emergency Plan Participation- Wednesday get through will check Emergency Plan Participation after that.

Clerk & Tax collector- 10 Dog licenses, 1 marriage cert, 0 genealogy, 2 misc. revenue, 3 building permits and 0 death certificates. Gave town a check for \$1732.50 for the General Fund. Tax Reconciliation With County- Certification Received Dog Control- License censes discussed. Do not agree a good idea.

Justice Report- Jane Lindquist reported on behalf of John Potter- The amount of fines \$25.00. and \$0.00 in surcharges and \$0.00 in civil fees. Total of \$25.00 for the Month of May 2022 and was turned over to the Town of Arkwright.

Assessor- 1/3 market value Towns worth \$93,000,000.00. People 41%, down from 41% market values going up 7.56% revalue

TCT Ministries Surety Bond- Talked to TCT Ministries regarding bond for Tower on timing of receiving the bond. Said we should have sometime in June. Needed to add Christopher Cannon on as an Additional insured due to his property agreement with TCT Ministries.
