WHEREAS, the rules and regulations governing the Community Development Block Program require that the Town of Olean is responsible for taking specific actions to affirmatively further fair housing (AFFH) practices in the Town of Olean; now, therefore, be it

RESOLVED, that it is the policy of the Town of Olean to implement programs to ensure equal opportunity in housing for all persons regardless of race, color, religion, sex, handicap or disability, or familial status or national origin, and that discrimination in the sale, rental, leasing, financing of housing to be used for construction of housing, or in the provision of brokerage services, because of race, color, religion, ancestry, sex national origin, handicap or disability, is prohibited by Title VIII of the Civil Rights Act of 1968 (Federal Housing Law); and be it further

REPORT OF TOWN OFFICIALS

SUPERVISOR

- The monthly bank statements were presented for review by the Board.
- Supervisor Parker said that the Indiana Avenue Sewer Project is complete. The Highway Department put in new drainage pipes in driveways, installed a large culvert, ground the road, prepped it for paving, paved the road, and corrected some drainage problems. The Town paid some money for professional fees and attorney fees that were not covered by the grant. All other costs were covered by the CDBG grant. Seven lateral connections into the new sewer line were installed by Genesee Valley Construction. The Town was granted \$250,000 and used \$247,473.77 so there was no cost to any of the residents.
- A satisfactory report was given to the Town of Olean from the Department of Agriculture and markets on the Town's kennel.
- Supervisor Parker would like to schedule a work meeting after the regular meeting on February 16th with the Board to discuss the information previously distributed to them on solar farms. All agreed.
- An Equal Employment Opportunity Policy statement will be displayed on the Town's bulletin board. All members of the Town Board agreed.
- A list of names and dates was made for the individuals who watched the Fair Housing Training video.
- The Town Board approved and signed the agreement with Catt. Co to spend Highway funds.
- The 2021 Organizational Resolution was approved by the Town Board and signed.

A RESOLUTION AUTHORIZING THE ISSUANCE AND SALE OF SERIAL BONDS FOR THE PURCHASE OF A 2021 TS00 KENWORTH TRUCK WITH PLOW EQUIPMENT

RECITALS

WHEREAS, the Town Board of the Town of Olean ("Town"), in the County of Cattaraugus, New York, desires to purchase a new 2021 T800 Kenworth truck with dump body and plow equipment; now therefore, be it

RESOLVED BY THE TOWN BOARD OF THE TOWN OF OLEAN, IN THE COUNTY OF CATTARAUGUS, NEW YORK (by the favorable vote of not less than two-thirds of all members of said Board) AS FOLLOWS:

Section 1. For the object or purpose of purchasing said new item, and to provide funds to defray the cost thereof, the Town of Olean shall issue its serial bonds of the aggregate principal amount of \$198,983.00 pursuant to the Local Finance Law of the State of New York.

- Section 2. \$198,983.00 is estimated as the maximum cost of said new item.
- Section 3. The plan for financing the purchase of said new equipment is as follows: the balance of the cost is to be provided by the issuance of serial bonds in the amount of \$198,983.00 pursuant to this Resolution.
- Section 4. The following determinations are hereby made:
 - (A) The period of probable usefulness of such equipment is fifteen (15) years.
 - (B) The subdivision of paragraph a of §11.00 of the Local Finance Law which is applicable in the circumstances is subdivision 11(a)(28).
 - (C) The proposed maturity of the obligations authorized by this Resolution will be five (5) years.
 - (D) The bonds issued pursuant to this resolution may be sold at private sale.
- Section 5. The Town of Olean shall issue its serial bonds in the amount of \$\$198,983.00 to finance a portion of such cost in accordance with the financial plan set forth above. Such bonds shall be dated approximately as of the date of delivery of such equipment and the power to fix and determine the exact date of such bonds is hereby delegated to the Town Supervisor.
- Section 6. Such bonds shall be numbered 1 to 5 inclusive, shall be in the following denominations, and shall mature in numerical order in annual installments in the years and amounts as follows:

2022 - \$39,796.60 2023 - \$39,796.60

2024 - \$39,796.60

2025 - \$39,796.60

2026 • \$39,796.60

The power to determine the date upon which installments shall become due and payable is hereby delegated to the Town Supervisor. The bonds shall be issued in bearer form without coupons and shall not contain a power to convert to registered form. The bonds shall bear interest at a rate not exceeding 3.5% per annum. Payments of such interest shall be evidenced by notation thereof on the bonds at the time of the payment.

- Section 7. Each of the bonds authorized by this resolution and any bond anticipation notes issued in anticipation thereof shall contain the recital of validity prescribed by Section 52.00 of the Law and said bonds and notes shall be general obligations of the Town, payable as to both principal and interest by general tax upon all the taxable real property within the Town without limitation of rate or amount. The faith and credit of the Town are hereby irrevocably pledged to the punctual payment of the principal of and interest on said bonds and notes and provision shall be made annually in the budgets of the Town by appropriation for (a) the amortization and redemption of the bonds and notes to mature in such year and (b) the payment of interest to be due and payable in such year.
- Section 8. Subject to the provisions of this resolution and of the Law, pursuant to the provisions of Section 30.00 relative to the authorization of the issuance of bond anticipation notes or the renewals of such notes and of Sections 50.00 and 60.00 of the Law, the powers and duties of the Town Board relative to authorizing the issuance of any notes in anticipation of the sale of the serial bonds herein authorized or the renewals of said notes and relative to prescribing the terms, form and contents and as to the sale and issuance of said bonds and of any notes or the renewals of said notes, are hereby delegated to the Supervisor as the chief fiscal officer of the Town.

Section 9. This resolution shall take effect immediately.
