This would require new underground fiber between Nat. Grid electric poles to the PA Rural Electric poles up on the 11 mile towards Millport. Armstrong is rebuilding infrastructure of RGE & Nat. Grid. Board suggested that Mr. Harder see if he could connect with the Tower in Alma using LSTAR. Board will discuss further as this involves property located in the Town of Alma.
