#### **Departmental Reports:**

Highway reported on activities for the month of March which included brooming roads, hauling in 1A stone for oil and stoning, removed old fuel tanks and replaced with new. Started taking plow equipment off ten wheelers and finished 2006 Sterling box and getting ready for paint.

Town Clerk's monthly report for March was submitted and filed. Collections totaled \$3,510.29 and disbursed as follows: Supervisor-A Fund: \$2,401.79, B Fund: \$100.00, SS1 Fund: \$411.09, NYS DEC license sales: \$451.41, NYS Animal Population Control program: \$146.00.

Town and County tax collection has ended. Final reports and disbursements have been submitted to the County tax office. Legal notice for Water Dist. 2 Extension mailed on 4/1/22 to 258 residents within proposed extension. Spring clean-up notices have been mailed. Town Clerk will be attending the annual State Conference for municipal clerks April 25-27, 2022. Local Government Conference is scheduled on June 9<sup>th</sup> at Houghton College. Registration forms have been distributed to staff.

Code/Zoning Office report was submitted and filed. There were 22 building permits issued in March with project values totaling \$5,672,769.00 and 8 Certificates of Completion with project values totaling \$673,278.00. The Zoning Board will have 2 hearings this month for variance requests.

Assessor's report was submitted and on file in the Clerk's office. Work is being completed for new construction and demolition. All properties will be valued for the May release of new assessments.

#### **Committee Reports:**

<u>Policing Agreement</u>- Councilman Cummings updated the Board on the status of a proposed policing agreement with Chautauqua Institution. The Institution has given verbal agreement. Next step will be to hold a meeting with the Institution, the Town and Sherriff's department to review

and issues and finalize the agreement. Once complete, it will be forwarded to the State Department of Justice for their approval.

Engineering- Mike Manning, engineer with Ramboll, submitted a meeting summary report on the well driller coordination meeting held on Feb. 22, 2022. Site location for the well is very wet and an access road will need to be developed. Drilling for the well could begin late May/early June. An application was submitted for a WIIA grant last November; results are still pending.

#### **Public Comments:**

Kris Martin requested the Board to consider a moratorium on green infrastructure for the Town to have time to develop stand-alone laws for wind energy, solar farms and energy storage facilities as most rural communities are unprepared for these types of facilities. Karen Engstrom submitted information to each board member regard local protections to consider with solar farms and encouraged them to review the Town's current solar law.

# Public Hearing- Water District 2 Extension South

Notice for public hearing was advertised in the Jamestown Post-Journal on April 1, 2022 and on the Town's website. A copy of the notice and extension map was mailed to all property owners within proposed extension.

Supervisor Emhardt opened explaining the reason for the extension. The water plant for Water District 2 is under an order of consent from the Environmental Protection Agency(EPA) to either upgrade the existing facilities or locate another water source. An engineering study found that upgrading the existing facilities would cost more than what the NYS Comptroller will permit so the only recourse for the Town was to find an alternate water source. After a few test sites, the Town was able to procure a place outside of the current district to drill two(2) wells. For these wells to service the district, the boundaries will have to be increased creating a benefit district. This benefit district would now be able to have fire hydrants installed lowering the current fire insurance rating from 9 to 6. It would also offer the availability of public water if needed. The original plan was to extend the current district to the well site only. The County Health Department contacted the Town requesting the extension to include the two(2) campgrounds located South of the site.

Residents in attendance questioned whether the new wells would affect the current wells already established or the creek. Mike Manning, engineer for Ramboll, clarified that only one well will be in operation at a time. Two wells are needed in the event something was to happen to the first. Other wells in the area should not be affected. Once the well is operational, a draw down test will be conducted to confirm this. The Department of Environmental Conservation (DEC) was notified during the SEQRA review process and submitted their recommendations and support. Mr. Manning also addressed the publics' concerns of possible groundwater containments by explaining the treatment process for commercial water.

Concern was made that residents would be forced to abandon their wells. Supervisor Emhardt stated that this extension does not currently provide for any new hook-ups. This would be a

'benefit' district in which fire hydrants will be installed and residents would have access to hook up to the public water supply available if needed.

# Resolution - Town of Chautauqua Water District No. 2 South Extension

**WHEREAS**, the Town Board of the Town of Chautauqua, Chautauqua County, New York, has duly caused to be prepared a map showing the boundaries of a proposed extension of Water District No. 2 in said Town (hereinafter, "Water District No. 2" or simply, the "District"), a general plan to drill new wells for and make some improvements to the said District, and a report of the proposed method of financing and operation thereof; and

**WHEREAS**, after the said map, plan and report was filed in the office of the Town Clerk of the Town of Chautauqua, the said Town Board did, on March 14, 2022, duly adopt an order reciting a description of the proposed extended boundaries, that the implementation of improvements within the Extension area was contingent on the receipt of grants and no-interest financing and would be charged on a benefit basis, the fact that a plan, map and report describing the same are on file in the Town Clerk's office for public inspection and specifying that said Town Board shall meet at the Chautauqua Community Building, 2 Academy Street, Mayville, New York on the 11<sup>th</sup> day of April, 2022, for the purpose of conducting a public hearing on the proposed extension of the district boundaries and to hear all persons interested in the subject thereof concerning the same, and

WHEREAS, copies of said order were duly published and posted according to law, and said Town Board did, at the time and place specified in said order, duly meet and consider such proposal and heard all persons interested in the subject thereof, who appeared at such time and place, concerning the same, and WHEREAS, the evidence offered at such time and place requires that the Town Board make the determinations hereinafter made;

**THEREFORE, BE IT RESOLVED**, by the Town Board of the Town of Chautauqua, in the County of Chautauqua, that it be and hereby is determined as follows:

- (1) The notice of hearing was published and posted as required by law and is otherwise sufficient.
- (2) That all of the property and property owners, within the proposed extended district boundaries are benefited thereby.
- (3) That all of the property and property owners benefited are included within the proposed extended district boundaries.
- (4) It is in the public interest to extend the district as hereinafter described, and be it

**FURTHER RESOLVED** that the Town Board does hereby approve the extension of the Town of Chautauqua Water District No. 2 to include the area described by the following boundaries:

ALL THAT TRACT OR PARCEL OF LAND situate in the Town of Chautauqua, County of Chautauqua and State of New York being part of the Holland Land Company's Survey bounded and described as follows;

BEGINNING at the centerline intersection between East Lake Road, (N.Y.S. Highway No. 430) and the centerline of Leet Avenue;

THENCE North 25°-03'-09" West along the centerline of said East Lake Road, a distance of 2,250± feet;

THENCE North 64°-50'-32" East, a distance of 500± feet;

THENCE South 25°-03'-09" East, parallel with said East Lake Road and distant 500± feet northeasterly therefrom, a distance of 2105± feet;

THENCE South 57°-30'-34" East, a distance of 1,246± feet;

THENCE North 89°-08'-33" West along the southerly line of Great Lot 11 and the centerline of Thum Road and further continuing westerly along the southerly line of Great Lot 14 in said Township and Range, a distance of 3,632± feet to the edge of water along Chautauqua Lake; THENCE continuing in a general northnorthwest direction along the edge of water of Chautauqua Lake, a distance of 12,833± feet to the approximate intersection between said edge of water and the northerly line of lands now or formerly deeded to Forty 4 Shore, LLC recorded in the Chautauqua County Clerk's office in Liber 2020 of deeds at page 3662, also being the established boundary limit of the Town of Chautauqua Water District Number 2 Service Area located to the north;

THENCE South 89°-24'-06" East along said northerly line of Liber 2020, page 3662 and said Water District Number 2 boundary limit, a distance of 136.4± feet to an angle point in the north line of said Liber 2020, Page 3662;

**FURTHER RESOLVED**, that future improvements in said extended district shall be funded by an assessment charged against the properties benefited on a benefit basis, offset by any funds received from grants and no-interest financing; and be it

**FURTHER RESOLVED**, upon the evidence given at the aforesaid public hearing, it is hereby found and determined that it is in the public interest to increase and improve the facilities of Water District No. 2 as extended in the Town of Chautauqua, Chautauqua County, New York, consisting of the installation of two (2) groundwater wells in the hamlet of Dewittville; construction of a support building of approximately 900 square feet to house pressure filters, water softening equipment, chlorination equipment, exterior clear wells, and electrical/instrumentation systems; approximately 14,200 linear feet of 8-inch diameter pipeline; tee connections and valving for future extensions; and including original furnishings, equipment, machinery, apparatus, valves, hydrants, appurtenances, and incidental improvements; and be it

**FURTHER RESOLVED**, that this resolution is subject to a permissive referendum in the manner provided in Article Seven of the Town Law and subdivision 3 of Section 209-e of the Town Law, and the Town Clerk is hereby authorized to post and publish notice of the adoption of this resolution in the manner provided by law.
