Executive Order 203 New York State Police Reform and Reinvention Collaborative

2021

i. Introduction

1. On June 1, 2020, Governor Andrew Cuomo issued an executive order directing the chief executive of municipalities that employ police officers to convene the head of the local police agency, and stakeholders in the local community to develop a locally approved plan for the strategies, policies and procedures of local police agencies. This plan must be offered for public comment to all of the citizens in the locality and after consideration of such comments, must be adopted by resolution no later than April 1, 2021.

2. Municipality Demographics

a. The Village of Belmont is located in the center of Allegany County, 3 miles south of Interstate 86. Our approximate population is 1000. The Village of Belmont was founded in the 1870's. The racial makeup of our Village is 96.11% White, 1.05% Hispanic, .95% Black and African-American, .11% Asian, 2.52% two or more races and .21% other race along (2000 Census). We have a K-12 school district in successful operation and the pride of our community, which is just outside of the Village limits. We are fortunate to retain a grocery store/deli, a library, bars/restaurants along with various other privately owned businesses. In 1859, we became the County seat. We hold a majority of county office buildings, departments and courts within our Village.

3. Agency Information

a. The Village of Belmont employs one full-time Police Officer who works approximately 40 hours per week. There are also four part-time Police Officers. Their office is located within the Village Hall. Our part-time Officers also work for various other Police Departments.

Based on our survey, the most common recommendations include:
