## **APPOINTMENTS & COMPENSATION:**

\*I would like to make the motion to appoint <u>Mrs. Holly Fischer</u> as planning board secretary with a term expiring December 31, 2021, with an hourly rate of \$10.00 per hr, not to exceed 10 hours per month.
