Mr. Masic spoke of a small portion of evidence he has gathered specifically pertaining to former Franklinville Supervisor Lorrie Fisher, Ginger Schroder, Building and Code Officer Lonnie Farrington and Dog Control Officer Kay Farrington. Mr. Masic is hoping to finally receive the justice for his family.

Mr. Masic voiced concern for another family they feel has been targeted and harassed.

Mr. Green voiced his concern for the Masic Family.

Mr. Tinelli thanked everyone for coming forward to voice their concerns. The Franklinville Town Board will continue reviewing content as well as be compliant. Mr. Tinelli stated the "Franklinville Town Board will not put up with harassment from anyone, and to please let us know if there is any further harassment." Mr. Tinelli spoke of the Town of Franklinville needing to take certain steps and go through the proper process of letting the public know the Boards decision.
