# Minutes for 05/10/2022, Supervisor's Report for May & General & Highway Abstracts for June:

When asked, board members responded yes, they had reviewed the minutes, reports and abstracts.

<u>The Supervisor's Report</u> showed the general fund received \$31,470.99. The highway fund received \$175.76. Disbursements include \$62,064.05 for general and \$26,142.09 for highway.

<u>The June Abstract #06</u> dispersed \$60,576.66 from the General Fund and \$42,078.25 from the Highway Fund On the motion of J. James and seconded by Farwell the reports were accepted as presented.

# **Clerk Comments:**

- Skylighters of New York has submitted their information for the Cuba Lake July 3<sup>rd</sup> fireworks. The Board approved
- Iva Ann's on Main has submitted their liquor license
- Justice Court Audit resolution on the Motion of Farwell, seconded by Dan McGraw. All in favor, passed.
- NYSLRS Standard Work Day and Reporting Resolution for Elected and Appointed Officials for Allesia Heslin on the Motion of Farwell, seconded by J. James. All in favor, passed.

# **Assessor's Comments:**

- Grievance is over. 3 were granted, 1 was denied
- Final roll is set

<u>Police Department Comments:</u> In the month of May the department conducted 25 traffic stops, 3 in the Town, 3 in the Village, 7 on the Lake, 0 on I-86 for a total of 13 uniform traffic tickets issued. 7 motor vehicle accidents occurred, 4 in the Town, 2 in the Village, 0 on the Lake, and 1 on I-86. There were 156 calls for service.

- Two officers sustained minor injuries in May
- There was a recall on the SUV, it is still under warranty and has been repaired
- Radars were sent to Albany for recalibration and are back in service

<u>Ambulance Comments:</u> The Cuba Ambulance Service responded to a total of 12 calls to service in April of 2022. 7 of those calls were taken to Olean General Hospital, 0 were taken to Jones Memorial Hospital and 3 were

sign offs, 0 was mutual aid, 0 were standby, 1 was taken by Mercy Flight and 1 was DOA. 3 of these calls were critical care with Cuba handling 2 and Olean 10/MTS handling 1. 8 of these calls were in the Village of Cuba, 3 were in the Town of Cuba, 0 were on the lake, 0 was mutual aid to Friendship, 0 was mutual aid to Clarksville, 1 was to New Hudson and 0 were on I-86.

- Working on getting all EMTs their annual skills evaluations which is required by the state and due at the end of the month.
- Will be doing standbys for Dairy Days, The New Hudson Fire Department Horse Pull, and the July 3<sup>rd</sup> lake fireworks.

#### **Sewer Committee:**

- Flow meter valve was not working. The village will do an estimated read for the Town
- L. James contacted National Grid due to the meter being turned off. The meter is not in the Town's name it is in someone else's name
- The meter is located on Barry Cummins' property, he will be bringing past bills to the Town Clerk
- Had one permit submitted, not sure when that will be completed for an add on to the district

# **Facilities:**

- There is a leaking hose in the police garage bay, it will be piped outside to prevent further leaks inside
- Caution paint in front of the building has been refreshed.
- The parking lot paint is on hold until the lot has been re-stoned
- Preen and mulch put down around flagpoles, new flags are up
- Additional camera installed in court room hallway
- Installed lockbox in case someone locks themselves out
- The sign awarded to the Town from the Chamber of Commerce will be installed by the Town

## Dog Control Comments: Linda Botens is filling in while DCO Justin Sweet is out for military action

- 5/25 6:55pm received a phone call, people concerned about a dog tied to a tree, having seizures, foaming at mouth-people could not give an exact address-off the Haskell. I asked for an exact address, will call me back (Sounds like cruelty case!) If I get an exact address, will notify police! Phone no. 585-981-0007
- 5/27 talked to the person from above call on 5/25 -could not find the dog, suggested it was tied to a tree on a Jeremiah Wilson <u>BUT NOT</u> sure, since this is a possible cruelty, I suggested they call the SPCA. I will notify police
- 5/31 Received a call 3:00pm a lost dog since Sunday on Spring Valley Road and South Road took their number if I see anything or I am notified (Jean Searl 818-385-5045)
- Received a call at 1:41pm loose dog on Rt. 20. Could not give exact location of where dog was at. She will continue to look and return a call to me! (Will wait rather than do mileage, NOT knowing where dog is at exactly) (PS -on my way to Friendship I did look for the dog)

- Deck framing inspection on South Shore

- Follow up on an open complaint on Spring Street
- Working with the County to fix some 911 numbers

- Currently, Justice Szucs of Friendship has been helping out with recusals from our court until we appoint a new Judge
