WHEREAS, the Town of Allegany, County of Cattaraugus and State of New York, currently has two (2) elected Town Justices; and

WHEREAS, the term of office of one of the elected Town Justices will expire on December 31, 2023, and

RESOLVED, that pursuant to the provisions of New York Town Law § 60-a(2), the Town of Allegany hereby reduces the number of elected Town Justices to one (1), subject to permissive referendum, with the Town Justice position having an elected term of office expiring on December 31, 2023 being eliminated; and be it further

RESOLVED, that this Resolution is subject to permissive referendum as provided by New York Town Law Article 7, § 90-94; and be it further

RESOLVED, that the Town Clerk is hereby authorized and directed to publish notice of this resolution in the official newspaper of the Town, and post said notice on the official signboard of the Town, within ten (10) days of the adoption of this Resolution; and be it further

RESOLVED, that this resolution shall take effect thirty (30) days after adoption, or until approved by the affirmative vote of a majority of the qualified electors of the Town of Allegany, voting on such proposition, if within thirty (30) days after its adoption there be filed with the town clerk a petition signed by electors of the Town qualified to vote in number equal to at least five (5) per centum of the total vote cast for governor in the town at the last general election, but shall not be less than one hundred (100) in a town of the first class.

#46-RESOLUTION OPPOSING GOVERNOR HOCHUL'S BAN OF GAS STOVES AND OTHER NEW FOSSIL FUEL HEATING EQUIPMENT

Motion: Supervisor Higggins 2nd: Councilman Cooper

WHEREAS, Governor Hochul's State-of-the-State address contained a proposal to prohibit the sale of new fossil fuel powered heating systems by 2030 for single-family homes and smaller buildings and by 2035 for commercial buildings and larger buildings, and

WHEREAS, Governor Hochul is further calling for zero-emission new construction, with no on-site fossil fuel combustion by 2025 for smaller buildings and by 2028 for larger buildings, and

WHEREAS, President Biden and the White House have come out against any prohibition

Of gas stoves, and

WHEREAS, the Governor's ban is intended to help address climate change, but this government mandate is more of a burden on our region's working-class residents and will have a devastating effect on restaurants, businesses and manufacturing facilities when they have to convert to all electric, and

WHEREAS, the cost to convert a house to electric will result in excessive costs to homeowners and would not include any kind of backup system in the event of a power outage, and

WHEREAS, the conversion to electric will create unnecessary and excessive financial burden and hardship for businesses that compete on a national or global level, and

WHEREAS, any such ban is likely to push many businesses out of the state which would contribute to accelerated population loss of those already burdened with high tax rates, the high cost of living, other unreasonable government mandates, reckless spending by the government, and unrealistic environmental mandates not consistent with our geographic region, and

WHEREAS, a ban on natural gas appliances and other fossil fuel heating equipment is not feasible for Western New York with its harsh winter weather and an exposed electrical infrastructure, and

WHEREAS, current technology that is expected to replace gas appliances, such as space heating, does not work well in our climate; this fact was noted in the recent Climate Action Council's report which proposed requiring two (2) heating sources for New York residents who live in areas that are frequently extremely cold, and

WHEREAS, electrical appliances have more moving parts, are expensive to maintain and repair and have been shown to be less efficient and therefore cost more to generate the same amount of heat than natural gas appliances, and

WHEREAS, mandating the purchase of electrical appliances is an unnecessary burden to be placed on families across New York State at a time when cost of living increases have significantly outpaced wage growth, and

WHEREAS, with higher costs across the board, energy bills will increase by excessive amounts for residents, further exacerbating the recent price spikes in food, transportation and general merchandise, and

WHEREAS, the costs to bury power lines, increase renewable energy infrastructure, and increase the capacity of transformers will be passed on directly to consumers in the form of increased energy costs, and

WHEREAS, the costs of upgrading in-home electrical panels will cause financial hardship on many homeowners, especially those owning older homes, in our geographical area, and

WHEREAS, any proposed ban on fossil-fuel powered heating equipment and appliances will cause severe hardship on the home owners and commercial businesses within the Town of Allegany, the County of Cattaraugus and Western New York State, now, therefore, be it

RESOLVED, that the Town Board for Town of Allegany hereby opposes the Governor's plan to ban natural gas heating and appliances as not feasible or warranted for the Town of Allegany, County of Cattaraugus and Western New York State, and be it further

RESOLVED, that certified copies of this resolution be forwarded to Governor Hochul, the Western New York Delegation to the New York State Senate and Assembly, New York State Association of Towns, Association of Counties, and any other party deemed necessary and proper.
