SUPERVISORS MANAGEMENT REPORT:

- Verizon will be using the tower on Fox Valley Road to boost reception for Verizon customers in the area.
- The senior citizen exemption for real property tax has not been increased since 2007. The Town Board needs to address this issue for updating.
- GoBike bike stand locations have been researched. Stands have not been placed yet.
- A town meeting will be held for Ashford residents regarding the Main Plant Processing Building Demolition at WVDP with opportunity to have questions answered.
- ECA asked Supervisor Pfeffer to be present at an informational forum focusing on modular reactors and provide suggestions to municipalities as the research and planning process occurs. The experiences in Ashford will be helpful to other areas new to the issue.
- A grant application for security cameras will be submitted.
- Catt Co Sheriff has filled all positions with qualified recruits. Ashford has been awarded the COPS Grant and it is anticipated an additional recruit can fill the position.
- The municipal parking fence is in disrepair and the study result for the survey needs to be completed before the fence project can be done.

COMMITTEE REPORTS:

- Highway department is currently at full staff. Paving projects have been completed. Brush tractor has still not arrived. MRC has completed requested pickups.
- Code Enforcement officer reported several projects still being planned this season. Verizon has applied for permit in Ashford.
- Constable committee has researched area municipalities regarding payment for constabulary services.
- Planning board will be submitting the Solar Local Law Draft.
- Summer youth recreation is almost completed with the final event being the Bike Rodeo. Many activities have taken place at no cost to the town and also in conjunction with Machias youth recreation. One participant has been injured and insurance has been contacted.
- Restore NY Letter of intent for the West Valley Inn can be submitted on direction of the Ashford Town Board.
