Discussion of the Dog contract - the town attorney stated in quickly looking at it that we would have had to inform the Town of Franklinville by Sept 1st if we wanted to get out of the contract and he didn't know if the town of Franklinville would hold fast to that or not. Clerk Holmes stated that we no longer had any equipment or kennel and didn't know what it would entail to go back on our own. She stated that she could reach out to the state contact that she had to see if she could get any more information.

Mr. Scurr questioned about the historian and if any reports had ever been given or if the historian had done any work, clerk Holmes stated that she had never been there when the historian had so she did not know, also she stated that she had reached out to her a couple of times to fill out a civil service application but she had never shown up.

Mr. Westfall was asked if he could find out some information on cameras for the town hall as the board felt that there should be some on the outside for the October meeting.

### Public comment

Mrs. Vickman - stated that she felt that the proper procedure was not done for the candidates and wondered if the board could hold a meet the candidate night at the Town hall. Town Attorney stated that an ad could not be put in the paper by the town but it could be put on our website and facebook page

It was decided to hold a meet the Candidate night on october 19, 2022 at 6pm at the town hall

Resident Doug Thompson brought pictures of pot holes on various roads - Older Hill, Pigeon Hill Rogers Rd and that trees needed to be cut along the roads. Also questioned about email from the county real property that disagreed with the figures with what Inverengy was passing out-Mrs. Tilton will look into it

Taxpayer Jeff Peterson- stated that as Mr. Thompson was complaining about potholes but nothing is ever said about Laidlaw Rd which is a county rd and that is the worst road in town, feel it is a vendetta against Mr. tingue

Resident Doug Seymour thanked Mr. Kozak for coming up and talking to him

Councilman Mr. westfall said that Mr. Tingue should look at a pothole on Pigeon by Roblee
