Review SEQRA: Attorney Dwight Kanyuck explained the process to review SEQRA. The Town is lead agency for SEQRA, it acts like a planning board.

Resolution Issuing a Negative Declaration and Enacting Local Law 3, 2022 to Repeal & Replace the Local Law Providing For Solar Energy System Facility Regulations:

- **-PG 5:** Include list of chemicals and frequency used for cleaning panels.
- **-PG 6:** Panel height changed from 12ft to 15ft as panels are 15ft when at full tilt.
- **-PG 7:** Changing the screening language, to provide appropriate level of year round screening. Changed wording from tall grass to trees and shrubs.
- **-PG 7:** 75ft changed to OREZ regulation of 100ft from edge of right away-different on Rt 70 from other town roads.
- **-PG 8:** Vehicular paths changed to comply with NYS Standards for Erosion and Sediment Control and the Solar Energy System Stormwater Pollution Prevention Plan, and the Fire Code.
- **-PG 9:** Reference to impervious materials changed, shall be treated as hazardous materials.
- -PG 9: Snow removal combined to one location.
- **-PG 14:** If facility does not pull electric in a year it is considered abandoned. Town Board has the option to extend the decommission period from 150 days up to 6 months. Staci Derrenbacher asked how the town would know if there was no output at the facility. Board wants quarterly reports on facilities output so as to determine if it is ever abandoned. Reports will be submitted to the Town Clerk.

Jared Maker stated he works for NYSEG and he is concerned about the lines having too much of a load from the solar power, as they are already over 100% capacity.
