## BOARD MEETING Meeting Minutes December 9, 2020 – via Zoom Call

## 1. CALL TO ORDER:

a. The meeting was called to order at 6:00 pm EST by the Chairman.

## 2. MINUTES:

## 3. CORRESPONDENCE:

## 4. VISITORS - L AST MILE PROVIDERS UPDATE:

- a. Tele-Star & Win-Win are losing customers based on complainants by customers largely due to ACTDC equipment failures.
- b. ACTDC needs a log tracking provided by the LMP following the locations, time, which equipment is failing, etc. And ACTDC needs Tickets filed through Conxx (in charge of our maintenance).

## 5. INFRASTRUCTURE:

## a. TOWER UPDATES:

- i. ACTDC technical advisor, Wayne Hawley, is putting together a list of all the current troubleshooting issues with the current system. Current issues include:
- ii. BOLIVAR TOWER: Bolivar Tower had an issue with a downed radio, which has since been replaced and the tower is operational.
- iii. ANGELICA AND CUBA TOWERS: Angelica and Cuba towers are not operational. Angelica tower has a power supply issue, which is being worked on, and the Cuba tower has a radio frequency problem.
- iv. COUNTY BUILDING MICROCELL: The microcell at the county building might be overload, will further investigate. Some sectors are dead, waiting for replacement radios (960+ days)

## b. OTHER TOWER RELATED UPDATES:

i. The contract for a microcell at WXXI is worked on. Our Technical Supervisor assessed the cost of installing equipment (est ~4K)

## c. PHASE OUT OF CURRENT 365 STANDARDS ON EQUIPMENT:

- i. Allegany County/ACTDC has applied for several state and federal grants covering the replacement of these systems and was approved for these grants. ACTDC has already started the process of ordering radios and storing quotas. The new radios come with a new tax, est. \$2.50 per customer per month.
- ii. Dec Update: On schedule for installation in late Feb/ early March 2021.

## 6. FINANCIAL:

- a. The approval of the bills from December 2020 was approved on separate motions:
  - i. To pay the First Light (Internet) bill was approved on a motion by Brent Reynolds and seconded by Dwight Fanton.
  - ii. To pay the Complete Payroll bill was approved on a motion by Brent Reynolds and seconded by Craig Clark.
  - iii. To pay the Ryan Cool (Wages) bill was approved on a motion by Brent Reynolds and seconded by Dwight Fanton.
  - iv. To pay the BBS Accounting LLC bill was approved on a motion by Brent Reynolds and seconded by Jonathan Dennehy.
  - v. To pay the NYSEG bill was approved on a motion by Dwight Fanton and seconded by Brent Reynolds.
- b. ACTDC requests Win-Win Wireless pay their overdue bills and resume their monthly payment. Due to an issue with online tracking software, there was a 5-6 month period where ACTDC invoices were estimated with help provided by the LMP. But also due to explosive growth by both LMP, the bills were significantly higher than what the LMP was anticipating. ACTDC's new Treasurer will reexamine the bills during that period and report the results to ACTDC board. Once the new equipment is installed a new service agreement and billing structure will be enacted.
- c. ACTDC Treasurer realized that there have been no insurance payments in 2020, will further investigate.
- d. ACTDC financial gain/loss estimated for 2020 is approx. a -18.5K loss. This doesn't include the withheld payments from Win-Win.
- e. For 2021 and beyond, ACTDC will send out checks using the Bill Pay System from Community Bank. The motion to use to the Bill Pay system to print and send out checks from Community Bank was brought forth by Brent Reynolds and seconded by Craig Clark, and the motion was approved.

- f. ACTDC Treasurer planned a new simplified rate structure for how to bill the Last Mile Providers.
- g. PARIS report: ACTDC has begun the search for a company to work on the PARIS reports. And Richard Zink (ACTDC's Treasurer) now has access to the reports.

### **Senator George Borrello**

Today we took a giant step forward in my ongoing effort to make broadband available to families, schoolchildren and businesses across the Southern Tier. At a press conference this morning in Little Valley I, and my colleague Assemblyman Joe Giglio, announced a collaborative effort between broadband providers and state and local officials to fast-track high-speed internet service across the region. Utilizing an existing 115-mile long fiber-optic trunk line with excess capacity that cuts across Allegany, Cattaraugus and Chautauqua counties, we can speed the process of bringing broadband to underserved areas. Make no mistake, there are hurdles in our way, especially burdensome mandates and taxes from Albany that make bringing broadband to rural areas cost prohibitive. We are up to the challenge. Our mission now is to remove those barriers. I want to thank Patrick Coughlin, Chief Development Officer of FirstLight Fiber and David PihI, VP of Operations at DFT Communications for joining us today. Kudos also go to Dr. Sharon Huff, Superintendent of Cattaraugus-Little Valley Central School District, for hosting us this morning. Dr. Huff highlighted the need for broadband for schoolchildren and their parents forced to study and work from home.

No one can do this alone. Also joining us this morning were Cattaraugus County Legislature Chairman Howard VanRensselaer; Crystal Abers, Cattaraugus County Director of Economic Development, Planning and Tourism; Debra Root, Allegany County Legislator and Chair of the Development Committee; Richard Zink, Executive Director of Southern Tier West Planning and Development and Kier Dirlam, Allegany County Director of Planning.







### Armstrong Cable updates local officials on progress in Cattaraugus, Allegany counties By RICK MILLER Olean Times Herald

## Dec 6, 2020

Public officials participated in a virtual information meeting with Armstrong Cable representatives last week on progress in installing fiber optic cable to areas in Cattaraugus and Allegany counties without broadband access.

Shawn Begaj, Armstrong vice president for regulatory policy and interconnection, said the project had been delayed over negotiations to reduce state Department of Transportation permit fees and with National Grid over pole replacement policy. The pandemic has also added to delays, he said.

Armstrong was able to reduce the DOT fee from \$67,000 a mile to \$13,000, which will mean more funding available to continue to expand fiber optic cable, Begaj said. Armstrong is installing 4,000 miles of fiber optic cable to 43,000 homes in five counties including Cattaraugus and Allegany counties. That is 16,000 more homes than in the census tracts Armstrong was awarded.

Begaj said some parts of the system in Allegany County are up and running while installation and hook-ups continue. Site will begin on the Cuba hub next week and installations could start by the end of January.

Other hubs where cable will be installed and hookups will be offered include Portville, Franklinville and Delevan in Cattaraugus County as Armstrong moves from east to west in its buildout. Armstrong also plans hubs for systems in West Valley, Salamanca, Allegany, South Valley, South Dayton and Randolph.

Begaj said that while much of the work in Cattaraugus County will be done in 2021, there will still be parts in the western part of the county from Randolph to South Dayton that won't be completed until 2022.

Crews are capable of installing between 6 and 10 miles of cable from a hub each week. The target dates, he said, are on the website <u>armstrongny.com</u>. Put your address in the box and it will show you where you are in the system, Begaj said.

Begaj thanked Cattaraugus County officials including Crystal Abers, director of the Department of Economic Development, Planning and Tourism for their assistance in bringing the issue of excessive state permit fees and the National Grid issue over pole replacement to light.

"We wouldn't be as far along without Cattaraugus County's help," Begaj said. Some of the expansion may include federal funding from the CARES Act for pandemic relief. Armstrong has installed 2,000 miles of fiber optic cable over the past 1½ years. They are ready to break over the Cattaraugus-Allegany county line.

Cattaraugus County legislator Don Benson of Allegany asked why places like St. Bonaventure and the Allegany-Limestone Central School District weren't included. Begaj replied the NY Broadband initiative is to expand broadband services, not offer competition. He also told Benson the cable would extend down South Nine Mile Road. Ellicottville Central School Superintendent Bob Miller asked about service to Humphrey, where several families with children who need to use computers for remote learning. "The kids are on an island," he said. "They can't get cell service or internet."

Begaj said Armstrong is in an accelerated mode because it realizes COVID-19 has made everything so much worse.

Armstrong specializes in providing broadband service in areas with around 10 homes per mile, but some hubs have only one or two per mile, Begaj said. Armstrong plans to offer service up to 1,000 feet past the census block boundaries the company was assigned. That could add another 4,500 hookups in Cattaraugus County. Asked about progress in northern Allegany County by County Legislator Judy Hopkins, Begaj said 4,500 locations are on live cable which is ready to go. The Armstrong marketing department reaches out with mailings and phone calls to residents when installation is available.

"Go to the website and watch for an area to turn green (from yellow), Begaj said.


