UPDATE EMPLOYMENT STATUS FOR TREVOR ENTERLINE

Mr. Bowen made the following motion: That Trevor Enterline has been issued both his New York State Dept. of Health Grade 11A Water Operator License and a New York State DEC/NYWEA Grade 2A Wastewater Operator License and that he be approved as Dual License Status with his payrate be set as established on the payrate schedule of the 2021 Organizational Meeting. Also, on the recommendation of the Water/Sewer Superintendent that he be appointed as Water and Sewer Deputy Superintendent. This was seconded by Councilman Rowe. ROLL CALL VOTE: Mr. Chimera YES, Mr. Trevelline YES, Mr. Rowe YES, Mr. Bowen YES. Mrs. Hathaway ABSENT. Carried.

UPDATE ON SEWER LINE 1 REPLACMENT

Supervisor Bowen stated that the contractors have begun to clear the land behind the properties to start the repair work to the sewer main on West Main Steet.

UPDATE ON CLEAN CHOICE ENERGY SPECIAL USE PERMIT

Attorney Ben Wisniewski, reviewed the application for the Special Use Permit for a Solar project at 5246 Route 76. He explained that this project did not include a battery storage component. The following steps need to be taken before the board can consider:

- 1. The permit will be reviewed by the Town Zoning Code Officer.
- 2. The Code Officer will meet with Mary Steblein, of LaBella for engineer and environmental review of the application.

- 3. A Deposit of 1% of the cost shall be submitted to the Town.
- 4. A complete application will then be submitted to the Town Planning Board for their review and then to the Town Board for final review.

SOUTH RIPLEY SOLAR PROJECT UPDATE

Mr. Wisniewski stated that there has been no revised application made by ConnectGen in response to the deficiency letter.

Mr. Wisniewski stated that the Town Supervisor, The County IDA, and Ripley Fire Commissioner representatives met with ConnectGen to discuss a Community Host Agreement on the proposed South Ripley Solar Project.

BATTERY STORAGE LAW UPDATE

Mr. Wisniewski informed the board that he is working on the updates to the proposed Battery Storage Law. He reminded the Board the Battery Storage is not a permitted use in the Town's Zoning Law therefore will not be permitted until the new law is in place.

The Board Members had no questions for Attorney Wisniewski.

Mr. Spacht, Highway Superintendent reported that his department worked the ditching and tiling at the Town "Hut" and Park area due to the flooding in that area.

Councilman Rowe presented Mrs. Eddy's monthly Code Officer's report as attached.

PRIVILEGE OF THE FLOOR

Jim & Shelly Spacht, NE-Sherman Road both asked why the firemen's Attorney was not allowed to be involved with the joint meeting discussing the proposed South Ripley Solar Project's Community Host Agreement.

Attorney Wisniewski stated that there was no Attorney representation by any agency at this meeting. Mr. Wisniewski stated he discussed this with the firemen's attorney himself, and Attorney Davis did not voice any concerns with that decision.

Jim & Shelly Spacht also voiced their concern that Jim Spacht, South Ripley Fireman Chief, was not invited to attend the Community Host Meeting.

Attorney Wisniewski informed them that a Fire Commissioner was invited to attend the meeting in question by Supervisor Bowen as a courtesy, as the Fire Company was not initially made part of this discussion with the County IDA.

Shelly Spacht, voiced her concern that the Budget Work Session was not posted on the Town of Ripley Website. Mr. Bowen stated that the Works Session was posted on the Town's official sign board.

EXECUTIVE SESSION

Supervisor Bowen made the motion that the Town Board Members move into executive session to discuss personnel. This was seconded by Councilman Rowe and carried unanimously. 8:05 p.m.

Supervisor Bowen made the motion to close the executive session and reopen the regular Town Board Meeting. 8:15 p.m.
