Public Comments:

Ryan Schoelerman inquired about the millings pile on W. Lake Rd. adjacent to Iron Works. The Board explained that this was originally initiated by the State project on Rte 394 when they gave permission to the contractor to dump the milling in their current locations. Conversations with the property owner and 3rd party managing the site indicated this pile would be cleaned up by October 2021 which was delayed due to illness. The Town was told they are in the process of removing it. The pile was currently reground due to hardening but nothing new has been added.

Mr. Schoelerman and Karen Engstrom informed the Board that this was not the case in which they both observed 4 new loads brought in on or around June 27th.

Richard Reiser spoke on behalf of the Chautauqua Property Owner’s Association inquiring about the powers of the Town Constables in the Institution and why they are not part of the emergency 911 system.

Councilman Akin explained the reason for the change in the department and their use of the 911 system. In the past, the Institution’s Police Department was deputized by the County Sheriff’s office. In 2016, according to the NYS Sheriff’s Association, a policy change removed this authority which also resulted in the department being removed from the emergency radio system. The Institution requested the Town to establish the Office of Town Constabulary appointing all staff of the department as Town Constables so that they would be able to continue their current operations and get back on the emergency radio system. It was later found that only as an established policing department would they be able to continue as they were. The Town created a committee to work with the institution on an agreement in which the Town would establish a Town Police Department. This process has fallen flat due to staffing issues in the Institutions security department. Attorney

Seachrist stated he would email Mr. Reiser more information on Town Constables along with the section of Criminal Procedure Law defining their duties.

Departmental Reports:

Town Clerk report was submitted and filed. Fees collected for June totaled \$5,166.56 and disbursed as follows:

Supervisor-A Fund: \$4,363.12 B Fund: \$200.00, SS1 Fund: \$407.06, SW3 Fund 955.10 NYS DEC license sales: \$420.44, NYS Animal Population Control program: \$113.00, Dept. of Health 270.00. 12 Marriage licenses were issued, and 35 record requests completed. Quarterly billing for Sewer Dist. 1 and Water Dist. 3 were mailed June 30th. Current lease for mail meter expired. New 5-year lease was negotiated with Lineage. New meter will be installed end of June. A 3rd party was obtained to mail Town/County tax bills locking in a lower postage rate before the July 10th increase. New bills will be printed on perforated paper, barcoded and will run through a double address verification process making collection more efficient for both the taxpayer and collector.

Code/Zoning Office reported and on file. A total of 16 building permits were issued , 12 Town and 4 Village, with total project value of \$276,490.00 and 59 Certificates of Completion issued with project values totaling \$2,551,757.00.

There were 3 zoning cases for the Town. An application to modify an existing Special Use Permit to expand a gravel pit was tabled to August. Two variances were granted for a storage building and deck addition in the Residential-Lakeside district. One application was referred to the Village of Mayville requiring variances for a house addition in the R3 Lakeside District.

Highway report submitted and on file. Entrance of Point Chautauqua (Leet Ave.) and shoulders were blacktopped as well as shoulders on Potter Rd. Mowing roadsides and Ditching on Elm Flat and Burdick Rd. Chip sealing 15 miles of road.

Assessor's report was submitted and filed with the Clerk's office. Final Assessment roll for 2022 is complete and has been submitted to Chautauqua County and New York State Office of Real Property Tax Services.

Water District 4 Extension- Petitions

Petitions were submitted by residents requesting municipal water to be extended from Water District 4(Mandolin Ridge) to the Village line servicing approximately 200 residences. To date, 108 signatures have been obtained in favor of the extension. The Board agreed to move forward with obtaining a map, plan and report to check the feasibility of an extension to this area. Residents in attendance were encouraged to obtain more signatures in the meantime. No action of the Board required at this time.

Local Law 3 of 2022

Be it enacted by the Town of Board of the Town of Chautauqua, County of Chautauqua, and State of New York, as follows:

SECTION 1. AUTHORITY

This local law is promulgated pursuant to the authority granted by:

1. Article IX of the New York State Constitution, §2(c)(10);
2. New York Statute of Local Governments, §10(1) and (7);
3. New York Municipal Home Rule Law, §10(1)(i) and (ii) and §10(1)(a), (11), (12), and (14);
4. New York Town Law §130 (11)(peace, good order and safety), (15)(promotion of public welfare); and
5. New York Town Law §64(17-a)(protection of aesthetic interests), (23)(general powers).

SECTION 2.

A new Chapter 133 is hereby inserted into the Town of Chautauqua Code, which shall provide as follows:

§ 133-1 Title.

This Chapter shall be known as the “Law to Regulate Mobile Food Vendors.”

§ 133-2 **Purpose.**

It is the purpose of this Chapter to protect the health, safety, welfare, and environment of the residents and property owners of the Town of Chautauqua. This section regulates the mobile food vendor industry and use and operation of mobile food vehicles within the Town of Chautauqua. The purpose of this regulation is to balance the potential impact on neighbors when Mobile Food Vehicles are in use and to protect other commercial businesses within the Town of Chautauqua.

§ 133-3 **Definitions.**

For purposes of this Chapter, the following terms shall have the meanings indicated:

MOBILE FOOD VEHICLE

A self-contained cart, trailer, or motorized vehicle in which ready-to-eat food is prepared, cooked, wrapped, packaged, processed or portioned for service, sale, or distribution.

MOBILE FOOD VENDOR

The owner of a mobile food vehicle or the owner's agent.

§ 133-4 **General provisions.**

- A. It shall be unlawful for any person to operate a mobile food vehicle within the Town of Chautauqua outside the Village of Mayville without first having obtained a valid mobile food vending license from the Town of Chautauqua as prescribed in this Chapter.
- B. It shall be unlawful for any person to operate a mobile food vehicle within the public rights-of-way or on public property anywhere within the Town of Chautauqua, except as permitted herein.

§ 133-5 **Approved locations.**

- A. A mobile food vendor may operate anywhere in the Town of Chautauqua outside the Village of Mayville except for the following:

(1) Adjacent to or within a radius of 100 feet of the nearest edge of any parcel on which is located a licensed food establishment, the kitchen of which is open for serving food to patrons. This requirement may be waived if the proprietor of the adjacent food establishment gives written consent, and such consent is visibly displayed within the mobile food vehicle.

(2) In any location that conflicts with any parking and vehicle and traffic laws, ordinances, rules and regulations of the State of New York, County of Chautauqua, and Town of Chautauqua.

(3) On any private property, unless the owner of such property gives written consent, and such consent is visibly displayed within the mobile food vehicle.

§ 133-6 **License required; application; conditions.**

- A. Any person desiring to operate a mobile food vehicle shall make a written application for such license to the Code Enforcement Officer, on forms provided, which shall include the following:

(1) Name, signature and address of each applicant and each corporate officer of the mobile food vehicle vending corporation.

(2) A valid copy of all necessary licenses, permits or certificates required by the County of Chautauqua, the State of New York or any subsidiary enforcement agencies or departments thereof, including, but not limited to, a valid New York State Department of Motor Vehicles registration and certificate of inspection and valid driver's licenses of all vehicle operators.

(3) A signed statement that the vendor shall hold harmless the Town and its officers and employees for any claims for damages to property or injury to persons which may be occasioned by any activity carried on under the terms of the license.

(4) Insurance.

(a) The vendor shall furnish a certificate of insurance evidencing that the vendor possesses and maintains such public liability, food products liability, and damage to property or bodily injury, including death, which may arise from the operations under the license or in connection therewith. Such insurance shall provide coverage of not less than \$1,000,000 per occurrence. The policy shall further provide that it may not be canceled except upon 30 days' written notice served upon the Town of Chautauqua. A license issued pursuant to the provisions of this section shall be invalid at any time the insurance required herein is not maintained and evidence of continuing coverage is not filed with the Town of Chautauqua.

(b) In addition to the above-required certificate of insurance, the vendor shall also endorse, maintain and include the Town as an additional named insured on its underlying business commercial general liability policy.

B. Code Inspection. The Code Enforcement Officer will conduct a fire safety inspection of the mobile food vehicle as part of the process of issuing or renewing a mobile food vendor license.

C. Fee. The fee for a mobile food vendor license shall be \$100.00 per year, which amount may be adjusted from time to time by the Town Board. All vendors holding a license that has been revoked or permitted to lapse shall pay a renewal fee as set by the Town Board.

D. Conditions of License.

(a) A mobile food vendor license shall expire on January 1 of each year.

(b) A license shall not be transferable.

(c) Each license is valid only for the particular vehicle for which it was issued.

§ 133-7 **Conditions of operation.**

A. If operating on private property, the vendor must obtain and display in or on the vehicle evidence of permission granted by the owner of the property, in writing, specifying the days, times and specific location(s) for which permission has been granted.

B. Mobile food vehicles with a valid mobile food vending license may be operated by the vendor during hours as approved by the property owner.

(1) However, vendors may not operate mobile food vehicles:

(a) Before 9:00 a.m.; or

(b) After 9:00 p.m., Sunday through Thursday; or

(c) After 10:00 p.m. on Friday and Saturday for events open to the public or after midnight for private events.

C. All signage must be permanently affixed to the mobile food vehicle except each vehicle may use one sandwich board sign no larger than six square feet per side.

D. All mobile food vehicles must be equipped with trash receptacles of a sufficient capacity and shall be changed as necessary to prevent overflow or the creation of litter or debris.

E. No alcohol may be sold or dispensed from mobile food vehicles.

§ 133-8 **Compliance with other regulations.**

- A. The owner/operator of any mobile food vehicle licensed by the Town of Chautauqua shall comply with all provisions of federal, state, and local laws and ordinances.
- B. The owner/operator of any mobile food vehicle licensed by the Town of Chautauqua shall comply with all notices, orders, decisions and rules and regulations made by the Code Enforcement Office, the Chautauqua County Sheriff's Office, the Chautauqua County Health Department, or any other Town of Chautauqua department and/or agency.

§ 133-9 **Penalties for offenses.**

- A. Any person who violates any provision of this chapter shall be guilty of a violation. Each violation shall be punished by a fine not to exceed \$250 per violation.
- B. Closure for operation without license. Any mobile food vehicle operating without the required Town of Chautauqua license shall be immediately closed by order of the Town of Chautauqua. Every day of operation without a license shall constitute a separate violation and shall be punishable by a fine of \$250 per violation.

§ 133-10. **Hardship.**

Should any person affected by this Chapter suffer an unnecessary hardship in the carrying out of the strict letter of this chapter, such person may apply to the Town of Chautauqua Board in writing for a variance from strict compliance with this Chapter, with proof of such unnecessary hardship. For the purposes of this Chapter, unnecessary hardship shall not be the mere delay in being permitted to make an application or waiting for a decision on the application for a permit.

SECTION 3.

If any part or provision of this Local Law shall be declared invalid, void, unconstitutional, unenforceable by a court of law, all unaffected provisions hereof shall survive such declaration and this Local Law shall remain in full force and effect as if the invalidated portion had not been enacted.

SECTION 4.

This Local Law shall take effect immediately upon filing with the Secretary of State of the State of New York.

Resolution- Culvert Assessment Project

WHEREAS, Chautauqua Lake is an invaluable asset to Chautauqua County and the municipalities that border it including the Town of Chautauqua, but has been designated as an impaired water body and its health and usability are threatened; and

WHEREAS, the Town of Chautauqua (Town) and the Chautauqua Lake and Watershed Management Alliance (Alliance) are partnering to complete a stream culvert assessments project at two locations in the Town within the Chautauqua Lake Watershed that will have a positive impact on the environmental health of Chautauqua Lake; and

WHEREAS, the 2022 Consolidated Funding Application includes New York State (NYS) Department of Environmental Conservation (DEC) Non-Agricultural Nonpoint Source Planning Grant (NPG) program grant opportunities for water quality projects that require local matching funds as cash and/or in-kind service in the amount of at least 10% of the grant amount; and

WHEREAS, the total eligible project costs have been identified at \$33,000 resulting in planned NPG requested funding of \$30,000, and planned local match in the form of cash of \$3,000; and

WHEREAS, the Alliance is expected to commit \$1,500 in cash towards the required local match pending approval of its Board of Directors; therefore be it

RESOLVED, that the Town of Chautauqua will act as the primary grant applicant and authorizes a grant submission to the NPG grant program for the Town of Chautauqua Stream Culvert Assessments Project and if awarded, commits to providing \$1,500 cash toward the required local match, and if the grant is successful, that the Town Supervisor is authorized to execute the State Assistance Contract, submit project documentation, and act in all matters related to Project and state funding assistance

RESOLVED that the Town Board of the Town of Chautauqua, in the County of Chautauqua, hereby determines that the proposed Town of Chautauqua Stream Culvert Assessments Project, which constitutes the assessment by an engineer of stream culverts that may be in need of repair or replacement but does not commit the Town to undertake, fund, or approve any particular action that may constitute a Type I or Unlisted action, is a Type II action in accordance with 6 NYCRR Section 617.5(c)(24) and is therefore not subject to review under 6 NYCRR Part 617

WHEREAS, the Town will commit 5% of the total project cost, pursuant to the Smart Growth Community Planning and Zoning Program, in cash and in kind services;

NOW THEREFORE BE IT RESOLVED AND DETERMINED, that the Town of Chautauqua Supervisor is authorized to submit all required documentation for the Grant Application and, if awarded, execute the Grant Agreement with the New York State Department of State and any and all other contracts and documents necessary to bring about the Project; and that the Town of Chautauqua Supervisor to is authorized to coordinate with the Village fulfill the Town's obligations under the Department of State's Smart Growth Comprehensive Planning Grant Application and Agreement.

Whereas, the New York State Department of Environmental Conservation (NYSDEC) is currently offering \$4 million in Water Quality Improvement Program (WQIP) grants for projects through the Consolidated Funding Application (CFA)

Whereas, in accordance with the WQIP grant requirements, the Town has retained Ramboll for the engineering and design of the extension through an agreement executed on May 10, 2022

Now, Therefore, Be It Resolved, the Town Board agrees to expend up to \$1,000,000.00(One Million Dollars) to meet the 25% match requirement for the WQIP grant; and

Be it Further Resolved, the Town Board authorizes Ramboll to prepare and submit an application to NYSDEC for WQIP grant funding and all required supporting documentation for the SD-1-E1N project.

Whereas, the Town requested an updated map plan and report from Ramboll to check the feasibility of continuing the extension of public water to service the point Chautauqua area,

Now, Therefore, Be It Resolved, that the Town Board approves the expenditure, not to exceed \$7,000, authorizing the town supervisor to execute an agreement an agreement with Ramboll to update the map and plan report extending water to Point Chautauqua,

Be it Further Resolved, that this resolution is determined to be subject to permissive referendum as provided by General Municipal Law §6-c and Town Law §§90 to 94, and shall not take effect until thirty (30) days from the date hereof pursuant to Town Law §91, and that no expenditure shall be made prior to expiration of said 30 day period, and that no expenditure shall take place after said period if a Petition has been duly filed pursuant to Town Law §91 with further action of this Board.
