MOVING PROPOSED LOCAL LAW 1-2021 "TOWN OF RIPLEY SOLAR LAW AMENDING LOCAL LAW 1992-2 AS AMENDED, THE TOWN OF RIPLEY ZONING LAW"

WHEREAS, the Town has previously introduced a proposed Local Law, "TOWN OF RIPLEY SOLAR LAW AMENDING LOCAL LAW 1992-2 AS AMENDED, THE TOWN OF RIPLEY ZONING LAW" upon which the Town has previously held one or more public hearings and the said proposed "Local Law" now sits on the table;

RESOLUTION 95-2021

ADOPTION BY THE TOWN BOARD OF THE TOWN OF RIPLEY OF A RESOLUTION ADOPTING A NEGATIVE DECLARATION OF ENVIRONMENTAL SIGNIFICANCE FOR THE PROPOSED SOLAR LAW UNDER SEQRA

WHEREAS, the Town Board recognizes the emergence and growing use of solar energy as a renewable energy resource, and

WHEREAS, the Town of Ripley Zoning Law does not adequately meet the Town's objectives, which include:

- 1. To create synergy between solar energy system development while protecting the historic and rural character of the Town, maintaining the rural style of life, retaining active farm production, developing business, and keeping Ripley an affordable place to live.
- 2. To maintain the rural character of the town;
- 3. To preserve the agricultural base of land and farm operations;
- 4. To avoid, or if avoidance is impossible, mitigate the impacts of Solar Energy Systems on environmental resources such as important agricultural lands, forests, wildlife, waterways, unique views and other protected resources;
- 5. To encourage sense of pride in the community and allow local residents, farms, businesses, and government to take advantage of the potential financial benefits of solar energy systems;
- 6. To increase employment and business development in the Town of Ripley by furthering the installation of appropriately sited Solar Energy Systems;
- 7. To diversify personal and community energy resources;
- 8. To decrease the use of fossil fuels to produce electricity, thereby reducing the carbon footprint of electricity produced in New York State;
- 9. To protect environmental resources such as agricultural lands, forests, wildlife and their habitats, waterways, wetlands, unique views and other protected resources from the potential for adverse impacts from Solar Energy Systems;
- 10. To advance state renewable energy policy by promoting community solar development of an appropriate scale, and providing substantive standards for large Solar Energy Facilities sited in Ripley by the New York State government, and

WHEREAS, on or about May 13, 2021, the Town Board of the Town of Ripley (the "Town Board") introduced a proposed solar law by Resolution 73-2021, after considering input and recommendations from the Town Planning Board and the public, and

WHEREAS, adoption of the Proposed Solar Law would involve a change in allowable uses within at least one zoning district affecting 25 or more acres of the district, and

WHEREAS, on or about May 13, 2021, by Resolution 74-2021, the Town Board of the Town of Ripley found that the adoption of the current version of the proposed Solar Law would qualify as a Type I action under SEQRA, and

WHEREAS, on June 3, 2021 the Town Board of the Town of Ripley re- referred the Solar Law to the County Planning Board pursuant to GML §239-m, and

WHEREAS, on June 3, 2021, the Town Board completed Parts 1 and 2 of a Full Environmental Assessment Form to assess the potential for environmental impacts resulting from the solar law, and

WHEREAS, public hearings on the solar law were held on June 28, 2021, and then continued to August 12, 2021,

WHEREAS, written comments on the solar law were accepted until 4 pm on August 10, 2021, and

WHEREAS, the Town Board conducted work sessions on August 26, and August 31, 2021 to further consider public comments and potential changes to the proposed solar law, and

WHEREAS, the County Planning Board provided informal comments on the proposed Solar Law that did not require any changes, but that were considered by the Town Board during a meeting held on August 31, 2021, and

WHEREAS, The Town Bard has considered the content of the proposed Solar Law, communications from entities, and communications from the County Planning Board, and public comments, and determined that nor further changes ar required to Parts 1 and 2 of the FEAF, and

WHEREAS, The Town Board has considered any and all relevant public input, and

WHEREAS, The Town Board has completed Part 3 of a Full Environmental Assessment Form and identified the relevant areas of environmental concern discussed in the attached negative declaration of environmental significance, including potential impacts to agricultural resources; aesthetic resources; open space and recreation; and noise, odor, and light and

WHEREAS, the Town Board has thoroughly analyzed the relevant concerns discussed in the attached negative declaration of environmental significance, and has determined that no significant adverse environmental impacts will result from the proposed Solar Law, and

WHEREAS, the Town Board has provided a reasoned elaboration for why the environmental concerns that were identified and analyzed will not be significant, and

AND THEREFORE, the Town Board hereby finds that enactment of the proposed Solar Law will not have any significant adverse impacts on the environment.

AND THEREFORE, the Town Board further resolves to adopt a negative declaration of environmental significance with respect to the adoption of the proposed Solar Law.

AND THEREFORE, the Town Board hereby adopts the attached negative declaration of environmental significance and incorporates it herein.

AND THEREFORE, the Town Clerk is hereby directed to enter this resolution and the attached negative declaration of environmental significance in the minutes of this meeting.

AND THEREFORE, the Town Clerk is hereby directed to transmit this negative declaration and resolution to the appropriate agencies in accordance with the requirements of 6 NYCRR 617.12(b).

AND THEREFORE, the Town Clerk is hereby directed to transmit this negative declaration and resolution for publication in the Environmental Notice Bulletin ("ENB") as required under SEQRA, either by email at <u>ENB@DEC.NY.GOV</u> or by regular mail to ENB, NYS Department of Environmental Conservation, 624 Broadway, 4th Floor, Albany, New York 12233-1750.

RESOLUTION 96-2021

ADOPTION BY THE TOWN BOARD OF THE TOWN OF RIPLEY OF A RESOLUTION ADOPTING THE PROPOSED SOLAR LAW

WHEREAS, on or about May 13, 2021, the Town Board of the Town of Ripley (the "Town Board") introduced a proposed solar law, and

WHEREAS, the Town Board referred the proposed solar law to the County Planning Board, pursuant to GML §239-m, and

WHEREAS, the County Planning Board provided informal comments on the proposed solar law, which were considered by the Town, but ultimately did not result any modifications to the solar law law, and

WHEREAS, on or about May 13, 2021, by Resolution 74-2021, the Town Board of the Town of Ripley found that the adoption of the current version of the proposed Solar Law would qualify as a Type I action under SEQRA, and

WHEREAS, The Town Board prepared a Full Environmental Assessment Form, and

WHEREAS, The Town Board issued a Negative Declaration of Environmental Significance (a "Neg Dec") and passed a resolution adopting said Neg Dec, and

WHEREAS, The Town Board has satisfied its obligation under the New York State Environmental Quality Review Act ("SEQRA"), and

WHEREAS, a final version of the proposed Solar Law was placed on the desks of all Town Board members at least eight days before prior to this date, **NOW, THEREFORE**, it is resolved that the Town Board hereby approves and adopts Local Law 1 of 2021, the Town of Ripley Solar energy Zoning Law, as attached to this resolution.

AND THEREFORE, the Town Board hereby directs the Town Clerk to file the Solar Law with the New York State Secretary of State in Albany within five days. This must be done on the appropriate forms provided by the Secretary of State and in accordance with Municipal Home Rule Law §27. These must be completed in accordance with the Department of State's instructions (rules for filing local laws). When the form is complete, the Town Attorney is directed to certify it on the final page. One original copy must be mailed to the Secretary of State, Records and Law Bureau, Department of State, which is located in Albany, New York. After filing is complete, the Town will receive a post card from the Secretary of State verifying that the law was filed, which the Town Clerk is directed to file in the Town Clerk's office as proof of filing.

AND THEREFORE, the Town Board hereby directs the Town Clerk to publish the Solar Law, or a summary or abstract of the Solar Law, in a newspaper published in the Town, if any, or in a County newspaper having circulation in the Town.

AND THEREFORE, the Town Board hereby directs the Town Clerk to enter this resolution and the attached Solar Law in the minutes of this meeting.
