<u>Code/Zoning</u> Office reported issuing 47 building permits, 34 Town and 13 Village, with total project value of \$865,667.00 and 15 Certificates of Completion were issued with project values of \$835,461.00. There are 3 cases going before the zoning board this month.

<u>Highway</u> report submitted and on file. Working with North Harmony to blacktop Potter Rd. from Webber to County Rd. Shim patching for stone and oiling and mowing roadsides. Helped Village with their spring clean-up. Sold tanks through Auction International with gas tank selling for \$1,775.00 and diesel tank selling for \$5,100.00.

<u>Assessor</u>'s report was submitted and filed with the Clerk's office. Grievance Day for the 2022 assessment roll was held on Wednesday, May 25, 2022. Hearings were scheduled by appointment and took place in-person this year. All other property owners presenting a grievance form to the Assessor's office on or before May 25th that did not have an appointment were reviewed as mail-in.

Supervisor Emhardt met with residents looking to petition the Town for public water. This would end up being an extension of Water Dist. 4. Residents were advised of the procedure to establish a new district and were given petitions to obtain the required signatures to start the process.

Water and Sewer Projects

Mike Manning submitted a project update on the following projects:

Groundwater Supply for Water District No. 2- Atlantic Testing Laboratories submitted geotechnical report. Design documents are being prepared for submission to regulatory agencies. Well drilling activities started 6/06/22. Observation wells 2 and 3 have been completed. Well driller estimates 100gal/min. on one and 20gal/min on the other. Supply well screen ordered for TW-1 and order for TW-2 is pending particle analysis. Percolation tests will be completed June/July for waste bed design. Finalizing access agreement with Tarpon Towers for site access for drillers. Land acquisition for wells will be finalized by 9/30/22. Project has been submitted for DWSRF funding Resolution extending district was adopted by the Board on 4/11/22. Will need a bond resolution by the end of July to apply for the next round of WIIA grants.

<u>Administrative Order on Consent</u>- Ramboll will prepare next quarterly report due July 31,2022. <u>Sewer District 1 Extension 1 North</u>- Project is moving forward. Subcontracts have been executed for the required surveys and geotechnical reports. First site visits will be June 20th and 21st. Information will be forwarded to the Town Clerk to add to the Town's website.

Point Chautauqua- Updated Map, Plan and Report

Residents of Point Chautauqua petitioned the Town for water 10 years ago. A map, plan and report was conducted by OBG(Ramboll) showing the cost to expand the infrastructure would exceeded the NYS Comptrollers threshold to charge each resident. With the new infrastructure extension of Water District 2 adding a tap for this area, this extension would be more feasible. The current water tower is more than sufficient to supply this area and an updated map, plan and report will be needed. Ramboll will work on a proposal for the Boards review. No action required at this time.

Water District 4 Extension- Map, Plan and Report

Supervisor Emhardt reported on meeting with a group of residents interested in extending Water District 4 to properties between Chautauqua Institution and the Village of Mayville servicing approximately 300 residents. They were given petitions and told if 51% of the residents in this area sign agreeing to it, the Town would put in an RFP for engineering services to obtain the map, plan and report required to start the process.

Non-Agenda items/Discussion:

Town Police

Town is still waiting on the revised agreement from Chautauqua Institution. Supervisor Emhardt stated he would contact John Shedd directly to see where they're at on this.

Highway Department Improvements

Supervisor Emhardt stated prices came in for the new water department building at the highway and were found to be exorbitant at \$450,000.00. This project should be postponed until costs come down.

American Rescue Plan Act(ARPA) Funds

Part of the ARPA funds were used to do the preliminary work for the new water department building. Now that this project is on hold, Supervisor Emhardt would like to use these funds for the new water wells since a grant wasn't awarded grant and the project needs to move forward. No action is required to change projects for these funds.
