Jason Pearl, Highway Superintendent, had provided written report for the month of November, noting snowplowing, sanding and repairs normal for the time of year.

Mary Weber, Town Clerk presented a report for November and a check to the Supervisor for \$\$20.58 Total fees collected were \$374.00, \$353.42 was forwarded to NYS DEC for hunting licenses sold. There is an opening on the Board of Assessment Review for a 5-year term. No one had contacted any resident that would be interested in serving on the Board. Carrie Childs moved to reappoint Margo Pearl if she would accept the appointment. David Moshier seconded, and the motion was carried by 4 votes in favor and 1 absent. Mrs. Pearl was later contacted and agreed to accept the appointment.

Carrie Childs moved to accept the minutes from the November meeting as presented, second was made by Scott Andrews and the motion was carried by 4 votes in favor.

Josh Freundschuh moved to accept the officers' reports as presented, the second was made by Davis Moshier, and carried by 4 votes in favor.

General Fund invoices #128-141 totaling \$3928.02 and 1 prepaid \$70.78 and Highway Fund invoices #189-197 totaling \$6,563.39 were circulated and signed.

Josh Freundschuh moved to pay the bills as presented, second by Scott Andrews and the motion was carried by all votes in favor.

The meeting was adjourned at 8:00 P.M. by a motion from David Moshier, seconded by Josh Freundschuh and carried by 4 votes in favor.
