MINUTES OF A BOARD MEETING OF THE VILLAGE OF WELLSVILLE BOARD OF TRUSTEES HELD ON TUESDAY, JUNE 15, 2021, AT 6:00 PM AT THE TRUSTEE BOARD ROOM, 23 NORTH MAIN STREET, ALLEGANY COUNTY, WELLSVILLE, NEW YORK.

The regular board meeting opened at 6:00 pm with the pledge to the flag led by Police Chief O'Grady.

Mayor Shayler welcomed everyone to the meeting.

Trustee Pearson requested acceptance of the minutes from the Regular Board meeting held on May 24, 2021; Trustee Fahs seconded the motion. Carried.

Mayor Shayler asked for the visitors to present their topics. First was Janet Kemp and Bill Sweet who brought up their desire for the Village to pave Whitney Place, off of Maple Avenue. They indicated that it is nothing but a pothole and is so rough to drive across, it causes dizziness and nausea. They noted that a few years ago, the Village did put down millings, but they just end up getting plowed up with the snow in the wintertime. They are selling their home and feel they will have trouble selling the property in this condition. Trustee Roeske indicated that he would look into this, to include finding out if it was ever adopted as a dedicated street or not. DPW Director Whitfield is not present tonight, so Trustee Roeske will follow up with him at a later time and perhaps determine what bandaids are available if it is indeed not a dedicated street. Chief O'Grady remembered previous Whitney Place resident Liz Hurley coming to the Board in the past and her being told it was not wide enough to be a dedicated street. Attorney Buck noted that the property owners in that area would have to propose that the Village take ownership of the lane for it to be considered for future work.

Mayor Shayler asked Kate Murphy to present her topic next. Ms. Murphy began with a big thank you to the Village in honor of her brother, Pat McKinley, who was touched by the Proclamation for "Captain" Pat McKinley Day, June 12, 2021, and for all future June 12. Ms. Murphy noted that Pat had lost his voice on that day, and soon after lost his life, but she knows that he knew he was loved. The McKinley family thanks the Village of Wellsville for their thoughtfulness. Mayor Shayler stated that he appreciated her sharing this and that Pat was definitely a big part of the Wellsville community. Ms. Murphy stated her other reason for coming tonight was to request implementing a Village-wide yard sale, like many area communities already have. She noted that it would bring throngs of people to Wellsville who will likely stop and eat in restaurants, perhaps see houses for sale or even plant ideas for starting a business here. She had already collected

signatures from residents who would be interested in participating, and to perhaps make it an annual event. Mayor Shayler stated that the traditional Sunnydale sales are off this year, primarily because that planning had begun over 30 days ago, when the State still maintained a stricter stance on COVID restrictions. In place of an organized sale that weekend in September and to encourage those affected by not being able to have a large-scale sale then, Mayor Shayler has already waived fees for yard sales to take place during that regular weekend in September. And additionally, with Ms. Murphy's idea for a Village-wide sale to happen even sooner (the 2nd weekend in July), Mayor Shayler made a motion that the Village suspend the requirement for a yard sale permit fee (which is normally \$15) for the weekend of July 9, 10 and 11 of 2021. He added that those wishing to participate will still need to complete an application form. Trustee Fahs seconded the motion. Carried.

Mayor Shayler invited visitor Angela Glickstein to share her topic next. Ms. Glickstein invited the Mayor and Trustees to visit the exterior of the David A. Howe Library this week as there are landscapers from Weaver Landscaping working there. She continued, to then look across the road at the former municipal building to notice how much that location could use a facelift as well. She did commend the efforts of cutting the grass and trimming the overgrown trees and shrubs, but stated that the trees are half dead and are no longer attractive and are growing over the signage that is there. She obtained a couple estimates ranging between \$1,300 and \$1,650. Mayor Shayler noted that, as a municipality, we are required to get bids for Village work, and also that we will have COVID refund monies coming to Wellsville that could be used for these types of projects. He stated that we will talk more on this. Ms. Glickstein noted that she will return in August to see what the Board would consider doing. Mayor Shayler closed with a thank you to Ms. Glickstein and that her information was very well taken.
