Section 1. Authorization of appointment

The Town Board of the Town of Machias is hereby authorized to appoint not more than four (4) officers who shall be known as "constables" and who shall possess all the powers and duties of constables in civil actions and proceedings and all the powers of peace officers as provided in the Criminal Procedure Law. They shall be subject to the general authority and direction of the Town Board and to such orders and regulations as the Town Board may prescribe, not inconsistent with law.

Section 2. Remuneration

Constables shall be paid such salary as shall be established by the Town Board at its reorganizational meeting each year, and shall be entitled to collect the statutory fees allowed by law in civil actions and proceedings.

Section 3. Tenure

Constables shall serve at the pleasure of the Town Board, and shall be appointed by the Town Board at its reorganizational meeting each year.

Section 4. Repealer

Any previous local law or regulation inconsistent with this local law is hereby repealed.
