# **FEBRUARY REPORTS**

TOWN SUPERVISOR ANDERSON ACCEPTED THE TOWN CLERK'S REPORT IN THE AMOUNT OF \$4,778.00. THE CHECK TO THE TOWN TOTALED \$4,739.00. THE TAX COLLECTION AMOUNT RECEIVED TO DATE TOTALED \$6,946,251.11.

SUPERVISOR ANDERSON ALSO NOTED THAT THE FOLLOWING REPORTS HAD BEEN RECEIVED: ZONING OFFICER, CODE ENFORCEMENT OFFICER, ASSESSOR. TOWN JUSTICES, AND HIS TOWN SUPERVISOR'S FINANCIAL REPORT.

COUNCILMEMBER CRESANTI ASKED CODE ENFORCEMENT OFFICER SAMUELSON IF HE HAS BEEN CONDUCTING FIRE INSPECTIONS AND MR. SAMUELSON THEN PROVIDED A WRITTEN FIRE INSPECTION REPORT.

## DOG CONTROL OFFICER RESIGNATION AND NEW APPOINTMENT

MOTION BY COUNCILMEMBER SCHLEMMER, SECONDED BY COUNCILMEMBER CRESANTI: THAT THE RESIGNATION AS VERBALLY EXPRSSED TO TOWN SUPERVISOR ANDERSON, OF DOG CONTROL OFFICER, FLOYD KENT, BE ACCEPTED AND JOHN STOW BE APPOINTED AS DOG CONTROL OFFICER EFFECTIVE MARCH 1, 2023, AT THE BUDGETED RATE OF PAY.

TOWN SUPERVISOR ANDERSON READ THE FIRST REPORT SUBMITTED BY DCO, JOHN STOW.

TOWN SUPERVISOR ANDERSON THEN EXPRESSED AN INTEREST IN THE OLD FLUVANNA ELEMENTARY SCHOOL AS A POSSIBLE SITE FOR THE TOWN HALL AND TOWN ATTORNEY ROBINSON SAID HE HAD SOME INFORMATION ON THE MATTER THAT WOULD NEED TO BE DISCUSSED IN AN EXECUTIVE SESSION.

MR. ANDERSON ALSO NOTED THAT HE AND JIM WEHRFRITZ WILL BE ATTENDING AN UPCOMING SEMINAR ON HARMFUL ALGAL BLOOMS (HABS) SPONSORED BY CLARKSON UNIVERSITY.

#### **PUBLIC**

- 1. GREG KORCL, BAYVIEW ROAD EXPRESSED INTEREST IN PURCHASING A 30 FOOT PIECE OF PROPERTY ADJOINING HIS PROPERTY. IN LOOKING AT THE MAP OF THE AREA IT WAS DETERMINED THAT THE TOWN DOESN'T OWN OR HAVE ANY INTEREST IN THE PROPERTY. TOWN ATTORNEY ROBINSON SUGGESTED TO MR. KORCYL THAT HE CONTACT CHAUTAUQUA ABSTRACT TO SEE IF THEY CAN DETERMINE WHO ACTUALLY OWNS THE PARCEL IN QUESTION.
- 2. KIM AND JAKE STAHLEY, MEADOW DRIVE PRESENTED THE TOWN BOARD WITH A WRITTEN TIMELINE OF THE FLOODING THAT HAS BEEN TAKING PLACE ON THEIR PROPERTY SINCE THE DITCH BEHIND THE NEIGHBORS HOUSE WAS CLEARED. THE TIMELINE RUNS FROM 7/16/2021 THROUGH 1/19/2023. THE STAHLEY'S ARE ASKING THAT THE NECESSARY WORK BE DONE BY THE TOWN AS SOON AS POSSIBLE SO THEIR PROPERTY WON'T BE FLOODED AGAIN THIS SPRING. KIM STAHLEY SAID THEIR BASEMENT HAS BEEN FLOODED TWICE.

TOWN ATTORNEY ROBINSON SAID HE NEEDS TO COMPLETE THE PAPERWORK FOR THE NECESSARY EASEMENTS AND GET IT SENT OUT.

HIGHWAY SUPERINTENDENT HALLBERG SAID THE WORK CAN BE DONE AS SOON AS ALL THE EASEMENTS ARE RECEIVED BACK FROM THE PROPERTY. HE SAID THE WORK CAN START IN THE SPRING.

# COUNTY LEGISLATOR CHAGNON REPORTED:

- THE LEGISLATURE APPROPRIATED ARPA FUNDS TO REPAIR TRAIL SECTIONS AND BRIDGES ON THE OVERLAND TRAIL AT HARRIS HILL, TO DEVELOP AND IMPLEMENT A WATERWAYS MASTER PLAN FOR THE MARDEN COBB TRAIL, TO UPGRADE THE SHERMAN DPF SHOP FUEL SYSTEM, TO IMPLEMENT A LANDFILL TRAILER PURCHASE, TO PURCHASE ADDITIONAL EMS GEAR, TO PURCHASE ADDITIONAL SOFTWARD LICENSES FOR THE SHERIFF CIVIL OFFICE, TO IMPLEMENT A PILOT RAPID-RESPONSE EMERGENCY FUND FOR EROSION AND POLLUTION CONTROL, TO IMPLEMENT THE SHOVEL READY DEVELOPMENT SITES PHASE 2 PRIJECT, AND TO IMPLEMENT AN APPALACHIAN REGIONAL MULTI-STATE COLLABORATION PROJECT;
- APPROPRIATED FUNDING FOR THE CHAUTAUQUA COUNTY CONSOLIDATED CODE ENFORCEMENT STUDY, WHICH IS FUNDED BY A NEW YORK STATE DEPARTMENT OF STATE LOCAL GOVERNMENT EFFICIENCY PROGRAM GRANT WITH THE LOCAL MATCH PROVIDED BY THE CHAUTAUQUA REGION ECONOMIC DEVELOPMENT CORPORATION;

- PASSED MOTIONS CALLING ON NEW YORK STATE TO CONTINUE TO PASS-THRU-FEDERAL AFFORDABLE CARE ACT ENHANCED FEDERAL MEDICAID ASSISTANCE PERCENTAGE FUNDS, URGING NEW YORK STATE APPROVAL FOR A NEW BROOKS HOSPITAL, AND URGING NEW YORK STATE TO SUPPORT NATURAL GAS.

MOTION BY COUNCILMEMBER CRESANTI, SECOND BY COUNCILMEMBER CRIST: THAT HIGHWAY SUPERINTENDENT HALLBERG IS AUTHORIZED TO BID FOR 3 NEW TRUCKS: 2023 FORD F-250 REGULAR CAB 8' BOX, 2023 FORD F-250 CREW CAB 6 34' BOX, AND 2023 FORD F-250 CREW DCAB 8' BOX SERVICE BODY TRUCK (UTILITY TRUCK.

MR. ROBINSON NOTED THAT HE HAD PRESENTED THE BOARD WITH A DRAFT OF THE UPDATED NEW YORK STATE UNIFORM FIRE PREVENTION AND BUILDING CODE (THE UNIFORM CODE) AND THE STATE ENERGY CONSERVATION CONSTRUCTION CODE (THE ENERGY CODE). A PUBLIC HEARING ON THE UPDATED CODE WILL HAVE TO BE SET. THE BOARD DECIDED TO POSTPONE ACTION UNTIL THE APRIL MEETING.

#### LAKE CONSULTANT REPORT

JIM WEHRFRITZ NOTED THAT THE APPLICATIONS FOR HERBICIDE TREATMENTS ARE PREPARED AND READY FOR THE TOWN SUPERVISORS SIGNATURE.

JOHN JABLONSKI OF 5709 CHEDWEL SAID HE IS OPPOSED TO THE USE OF HERBICIDES IN THE LAKE AND WANTS THE PUBLIC TO HAVE MORE TIME TO COMMENT DURING THE PROCESS.

THERE WAS A LOT OF DISCUSSION AND IT WAS REPEATEDLY MENTIONED THAT THE PERMIT APPLICATION PROCESS IS UNDER THE CONTROL OF NEW YORK STATE DEC. THE TOWN OF ELLERY DOES NOT GOVERN ANY OF THE REGULATIONS. THE TOWN IS AN APPLICANT ONLY.

MOTION BY COUNCILMEMBER SCHLEMMER, SECOND BY COUNCILMEMBER CRESANTI: THAT THE TOWN SUPERVISOR IS AUTHORIZED TO SIGN THE HERBICIDE PERMIT APPLICATION AND ALSO, ANY OTHER PERMIT RELATED DOCUMENTS AS/WHEN NECESSARY.
