Mayor DeTine opened the meeting at 7:00 PM.

The Board pledged the flag.

Minutes of the previous meeting read and approved on a motion by Trustee Schmitt, 2nd by Trustee Grantier and carried on a vote of 5 ayes and 0 no's.

The Mayor introduced the new Deputy Clerk, Jeanette Stewart to the board.

Mayor DeTine reviewed the annual organizational meeting appointments, committees and policies and procedures. Motion to approve all made by Trustee Grantier, 2<sup>nd</sup> by Trustee Schmitt and carried on a vote of 5 ayes and 0 no's.

Motion to approve water and sewer billing adjustments made by Trustee Schmitt, 2<sup>nd</sup> by Trustee Evans and carried on a vote of 5 ayes and 0 no's.

Mayor DeTine reviewed the request from the Rotary for the Village to pay for one of the Porta - Potties for Amity Daze. Motion to accept the request made by Trustee Grantier, 2<sup>nd</sup> by Trustee Schmitt and carried on a vote of 5 ayes and o no's.

Mayor DeTine reviewed the request for the permit for the outdoor Fireworks Display on May 27, 2023. Motion to accept made by Trustee Schmitt, 2<sup>nd</sup> by Trustee Grantier and carried on a vote of 5 ayes and 0 no's.

Motion to close the regular meeting to hold the public hearing on the budget made by Trustee Schmitt, 2<sup>nd</sup> by Trustee Grantier and carried on a vote of 5 ayes and 0 no's at 7:15PM.

Mayor DeTine reopened the regular meeting at 7:45PM.

Eugene Smith was sworn in for the Village Justice position.

Justice Gominiak will stay on, until Gene completes the course that is scheduled for April 17 through the 21<sup>st</sup>.

Officer Zajicek reviewed the police report with the board. Motion to accept made by Trustee Evans, 2<sup>nd</sup> by Trustee Grantier and carried on a vote of 5 ayes and 0 no's.

Officer Zajicek informed the board that he talked to the kids at the Boces criminal justice program. He stated that there were a few who showed interest with the police department. Mayor DeTine asked Officer Zajicek what his thoughts are on doing some ride alongs with some of these students. Officer Zajicek stated that he has done some in the past with Wellsville's P.D. and he enjoyed the interaction with them.

Trustee Grantier thought this would be a great experience, but did express concern about confidentiality. He asked that the Village have them sign a waiver for the purpose of confidentiality.

Officer Zajicek agreed.

Officer Zajicek informed the board that he will be taking the Police car to Simmons and Rockwell to have the battery replaced, They are still having troubles with it.

Mayor DeTine informed the board that Kevin from M.A.C.E is working on some reports for the Village. He stated that he would give Kevin a call to see how they are coming.

Mayor DeTine informed the board that the water shut offs went well. Everyone on the list paid.
