The Organizational Meeting is as follows:

The Cuba Village Board Meeting will be held the second Monday of each month at 7:00 pm in the Cuba Village Municipal Building, 17 E. Main Street, Cuba, New York. A Committee Meeting will be held at 6:30 prior to the board meeting each month.

Freed Maxick/ Nicole Ryan is authorized to audit the Village books up to two times a year.

The Board of Trustees of Cuba Village agree to pay a fixed rate of .555 cents per mile when documentation has been submitted for authorization as mileage reimbursement to officers and employees of the Village who use their personal vehicles while performing official duties authorized on behalf of the Village. NO mileage reimbursement will be given if a Village vehicle is made available.

The Board authorizes the reimbursement of up to \$40.00 per day for meal expenses while traveling for conferences, and receipts for purchases with the Business name, date of purchase and cost listed. However, if meals are included and provided by conference fees, there will be no additional reimbursement. There will be NO reimbursement for tax or alcohol, and no reimbursement if itemized receipts are not submitted- expense logs and mileage forms will be provided and required for reimbursement at the following month board meeting.

Hotel rooms will be shared when more than one employee is in attendance unless employees are opposite gender, then two rooms will be reserved.

Members of the Village Board, Clerk Treasurer, and Superintendent of Public Works are authorized to attend conferences and schools as provided in Section 7B of the General Municipal Law.

Major conferences to be attended are: NYCOM Annual Meeting; NYCOM Fall Training School; NYCOM Winter Legislative Meeting; NYCOM Public Works, Parks & Maintenance School; Annual Highway School and Fall Highway Conference. The Village Clerk is authorized to invest Village funds as per the investment policy passed by the Village Board. The Board also authorizes the Clerk/Treasurer to pay prior to the monthly board meeting, payroll, utilities, health insurance and any contract payments.

WASTEWATER PLANT REPORT:

- The DMR was sent in for March (Clerk Unsure of date- using STP report- believe February) and all was within limits.
- The new tractor was picked up by The Dealership from Hornell to have some warranty work done, new parking brake cables and checked for a possible fuel leak. Roman picked it back up five days after it was picked up from the plant.

- Roman is having issues ordering UV bulbs due to supply and parts availability so Roman asked to have the budget line G00-8130-2 U.V. budget carried over into the new fiscal year if it comes down to it.
- He brought his 4-wheeler down and used it to roll the lawn at the STP
- Kevin Maine is setting us up for an energy audit at the STP as soon as possible to try and help figure out the increase in the cost difference in the bill.

CLERK/TREASURER REPORT: 4/11/2022 Clerk Report

- The NYS 1, NYS 45, and the Retirement report all have been accepted and paid. Reports were also sent to the Allegany County Worker's Comp. Office to H Bedow.
- Documentation continues to be requested by all Village employees for Covid-19 tracking and potential State reimbursement if instances occur.
- We still have not received a paid in full receipt for the payoff of the water tank.
- Corine and Lori worked to process water and sewer bills. Lori Printed, Postmarked, and Mailed them with Randy taking them to the post office Friday April 1.
- Lori sent septage invoices to send to dumpers for the month of March.
- Attended virtually several NYSOSC webinars and NYCOM Webinars.
- Worked with the LIHWAP Program again to assist with their ascertaining/confirming an account.
- The election was successful. Congratulations to all.
- Crossing Guard and Annual/Biannual Payroll was issued for March.
- A formal motion is required for Jeff and Roman to attend the conference in May, and Randy to attend a Water school Class in April along with room approval for the former.
- Required documents were sent to USDA Rural Development and Timothy McGill's Office (Bond Counsel) for the Water Improvement Project and the Street Sweeper purchase.
- Thirty day shut off notices were mailed to seventy seven customers/ property owners. Thursday April 14, 2022 will be shut off day. With a Village resident threating Village staff last week, Chief Burch said Cuba PD will have patrol available should a need arise. Some people have not paid their bill at all since April of 2020 and the back amounts total over \$35,000 with

more than \$18,000 being the actual property owner owing, and over \$7,000 as current tenants, and the remaining amounts tenants who vacated without paying. Shutoffs have not happened due to the Executive order from the Governor's Office prior to now, and the proper procedure has been followed for Thursday. This is the hard part of a small community; we are just doing our jobs according to the laws in place.

- Corine sat in on a refuse meeting with Trustee's Raub, Barnes, and Taylor. Two members of the public, and DPW Super. Hall were also in attendance.
- The Relevied taxes for last year were made whole to the Village account by Allegany County on March 23 totaling \$42,116.31.
- The NYSOSC released the Fiscal/ Environmental stress scores with the VOC at 0.0 (YAY!!!) for fiscal stress and 13.3 for environmental. A detailed report will be released in the coming two weeks from the Press Dept. at the OSC describing the numbers.
- The alarm system in the Clerk's Office requires an update. Doyle Security will make the updates if approved by the Board of Trustees.

TRUSTEE TAYLOR MADE A MOTION TO APPROVE THE ALARM UPDATE IN THE CLERK'S OFFICE UP TO \$1,000 WITH TRUSTEE E. MILLER OFFERING A SECOND. ALL IN FAVOR AND THE MOTION CARRIED.

Trustee E. Miller did inquire if the Village would be entitled to a discount as the service has not been working and was discovered to be faulty last week. Clerk Bump will inquire.

COMMITTEE REPORTS:

REFUSE- There is an upcoming meeting in Friendship on 4/20/22 with their committee to work through some issues.

PERSONNEL- Corine called Chris Cappelletti at CRCS and Heather Pfeiffer to inquire about the possibility of summer swimming and if lifeguards will be needed. There has still been no return phone calls. Send an ad to the paper if no response to advertise for staff.

FINANCE- There was a webinar for water rates education that Corine, Lori, Steve and Tom attended at the Clerk's Office. Jim and Tom will continue to work on water/sewer rates. The 22.23 FY budget is ready to vote on.


INFRASTRUCTURE- Make a post on the Village's Facebook social media page regarding grease in drains. No news yet as to whether the VOC received any grant funding.

At a meeting of the Board of Trustees of the Village of Cuba, Allegany County,
New York, held at the Village Offices in Cuba, New York, on the 11th day of April, 2022:

BOND RESOLUTION DATED APRIL 11, 2022 OF THE VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF CUBA, NEW YORK, AUTHORIZING GENERAL OBLIGATION SERIAL BONDS TO FINANCE THE ACQUISITION OF A SWEEPER TRUCK, AUTHORIZING THE ISSUANCE OF BOND ANTICIPATION NOTES IN CONTEMPLATION THEREOF, THE EXPENDITURE OF SUMS FOR SUCH PURPOSE, AND DETERMINING OTHER MATTERS IN CONNECTION THEREWITH.

WHEREAS, the purpose hereinafter described consists of the acquisition of equipment authorized to be undertaken by the authorized to be undertaken by the Village Board of Trustees pursuant to the Village Law;

WHEREAS, the Village hereby determines and finds that the proposed action hereinafter described constitutes a "type II" action under the State Environmental Quality Review Act of the State of New York and the applicable regulations thereunder ("SEQRA") which will not result in any significant adverse environmental impacts in that the purpose consists of the purchase of equipment, and such purpose is not subject to any further environmental review under SEQRA; now therefor, be it

RESOLVED BY THE VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF CUBA, NEW YORK (hereinafter referred to as the "Village"), by the favorable vote of not less than two-thirds of all of the members of such Board, as follows:

Section 1. The Village of Cuba shall undertake the acquisition of a sweeper truck, which may include original equipment or furnishings required in connection

therewith for such Village use (hereinafter referred to as "purpose"), and general obligation serial bonds in an aggregate principal amount not to exceed \$275,000 and bond anticipation notes in anticipation thereof (and renewals thereof) of the Village are hereby authorized to be issued to finance said purpose.

Section 2. The estimated aggregate maximum cost of said purpose, including preliminary costs and costs incidental thereto and costs of the financing thereof, is estimated to be \$275,000, and said amount is hereby appropriated therefor. The plan for financing of said purpose is to provide all of such maximum cost by issuance of obligations as herein authorized, to be offset and reduced dollar for dollar by the amount of grants received, if any, currently estimated to be \$46,000.

Section 3. It is hereby determined and declared that (a) said purpose is one of the class of objects or purposes described in Subdivision 28 of Paragraph (a) of Section 11.00 of the Local Finance Law, and that the period of probable usefulness of said purpose is fifteen (15) years, (b) the proposed maximum maturity of said bonds authorized by this resolution will be in excess of five years, (c) current funds required to be provided prior to the issuance of the bonds or notes herein authorized, pursuant to Section 107.00 of the Local Finance Law, to the extent applicable, if any, will be provided, (d) the notes herein authorized are not issued in anticipation of bonds for an assessable improvement, and (e) there are presently no outstanding bond anticipation notes issued in anticipation of the sale of said bonds.

Section 4. The bonds and notes authorized by this resolution shall contain the recital of validity prescribed in Section 52.00 of the Local Finance Law and such bonds and notes shall be general obligations of the Village and all the taxable real property in the Village is subject to the levy of ad valorem taxes to pay the principal thereof, and interest thereon, without limitation as to rate or amount, subject to statutory limitations, if any.

Section 5. It is hereby determined and declared that the Village reasonably expects to reimburse the general fund, or such other fund as may be utilized, not to exceed the maximum amount authorized herein, from the proceeds of the obligations authorized hereby for expenditures, if any, from such fund that may be made for the purpose prior to the date of the issuance of such obligations. This is a declaration of official intent under Treasury Regulation §1.150-2.

Section 6. The power to further authorize the sale, issuance and delivery of said bonds and notes and to prescribe the terms, form and contents of said bonds and notes, including, without limitation, the consolidation with other issues, the determination to issue bonds with substantially level or declining annual debt service, whether to authorize the receipt of bids in an electronic format, all contracts for, and determinations with respect to, credit or liquidity enhancements, if any, and to sell and deliver said bonds and notes, subject to the provisions of this resolution and the provisions of the Local Finance Law, is hereby delegated to the Village Treasurer, the Village's chief

fiscal officer. The Village Treasurer and the Village Clerk or Deputy Clerk are hereby authorized to sign by manual or facsimile signature and attest any bonds and notes issued pursuant to this resolution, and are hereby authorized to affix to such bonds and notes the corporate seal of the Village of Cuba.

Section 7. The faith and credit of the Village of Cuba, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such bonds and notes as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such obligations becoming due and payable in such year.

Section 8. After compliance with Section 9 hereof, this resolution shall be published in full by the Village Clerk of the Village of Cuba together with a notice in substantially the form prescribed by Section 81.00 of said Local Finance Law, and such publication shall be in each official newspaper of the Village, in the manner prescribed by law. The validity of said bonds and bond anticipation notes issued in anticipation of the sale of said serial bonds, may be contested only if such obligations are authorized for an object or purpose for which said Village is not authorized to expend money, or the provisions of law which should be complied with, at the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication; or if said obligations are authorized in violation of the provisions of the Constitution.

Section 9. This resolution is subject to a permissive referendum of the qualified electors of the Village of Cuba, pursuant to Section 36.00 of the Local Finance Law.

The motion having been duly seconded, it was adopted and the following votes were cast:
