TITLE: <u>Resolution Authorizing Appointments to Various Committees, Commissions, and</u> <u>Boards</u>

**WHEREAS,** NYS Town Law § 64(23) permits Towns to have and exercise all the powers conferred upon the Town and such additional powers as shall be necessarily implied therefrom;

**WHEREAS,** NYS Town Law §63 permits the Town Supervisor to appoint one or more Committees to aid and assist the Town Board in the performance of its duties;

**WHEREAS**, the Town Board has sought interested Town of Machias residents to serve on such Town entities through local advertising;

WHEREAS, several Town of Machias residents have expressed an interest in the same;

**WHEREAS**, the Machias Youth Commission was established on April 13, 1964, and Town Board appoints the Town of Machias Youth Commission on an annual basis and the Youth Commission administers the summer recreation program;

**WHEREAS**, the King Memorial Library was previously established as a municipal public library by the Town Board of Machias, and the NYS Board of Regents issued a provisional charter in 1947, and permanent charter in 1971 to the King Memorial Library, and the NYS Education Law § 260 (2) states that the Trustees of public libraries authorized to be established in Towns, shall be appointed by the Town Board;

WHEREAS, the following vacancies currently exist:
