The meeting was called to order by Supervisor Campbel at 5 P.M. Roll Call was taken.

Petitions and Requests from the floor

Commissioner Russel Hatch from the Franklinville Fire Department discussed the challenges of recruiting and/or retaining volunteers for the department. In 20 years, the number of members is at its lowest with about 20 active members. Many members receive the training then move onto a paying job.

Mr. Hatch has the board of commissioners interested in looking into a defined contribution program named **LOSAP** (**Length of Service Award Program**). This program has pension like benefits based on a points system.

- -volunteer makes 50 calls they earn 50 points
- -more points received if they hold an office, attend trainings, and take the calls
- -minimum age of retirement required
- -1-time payment or split into 2 payments.
- -sponsorship program, money goes into a separate fund
- -could have a look back provision.
- would have to be planned on and put into the Town Budget, all registered Franklinville voters could vote on this program at a commissioners meeting.

Supervisor Campbell asked if the money grows in the fund with interest.

Mr. Hatch replied that all money is invested and will create a return.

Councilwoman Hahn asked if the Town decides on how much to sponsor.

Mr. Hatch said there is a minimum and a maximum which includes:

Minimum of \$240.00 per person, per year Maximum of \$1200.00 per person, per year

Councilwoman Hahn asked if it is for all volunteers or do they have to be in our community.

Mr. Hatch replied with only Franklinville Volunteer Firemen, whereas if a member comes from a different community, they must be voted on by the Commissioners to allow a resident of another Town.

Mr. Hatch recommended searching LOSAP for more information.
